Dear Ms. Winfrey:

Brink's, Incorporated has owned and operated its business at 1351 Spruce Street at the corner of Spruce Street and Brooklyn Ave., near downtown Detroit for the past 50 years. We have recently purchased several residential parcels, west of our original property with the intention of developing an off-street parking lot to accommodate our growing business. The proposed parking lot is intended to serve the needs of Brink's staff and visitors.
