Dear Sir or Madam:

We are counsel to PTI QCS Realty, LLC. On its behalf we are submitting this letter as our Petition to Continue the Temporary Closure of Hildale between the Railroad right-of-way and Filer Street previously issued to Sherwood Food Distributors pursuant to Petition No. 1916 on May 4, 2005. A drawing of the area which has been temporary closed is attached to this Petition.

We received a Notice from the City of Detroit, Department of Public Works City Engineering Division that the Temporary Closure previously granted to Sherwood Foods has expired and a petition to renew this Temporary Closure must be submitted to the City Council.

PTI QCS Realty, LLC purchased this property in 2006 to facilitate the operations of PTI Quality Containment Solutions, LLC, an automotive supply and servicing company. Since purchasing this property, PTI Quality Containment Solutions, LLC has grown and now employs over 180 people. The company continues to be in an expansion mode and a continuation of the Temporary Closure would be vital for the continued suitability of the property for its operations. The Temporary Closure secures the property and prevents illegal dumping. It is our understanding that the Closure has been well received in the community and its continuation would not result in a disturbance within the community. We are hopeful that PTI QCS Realty, LLC's Petition to extend this Temporary Closure will be granted.

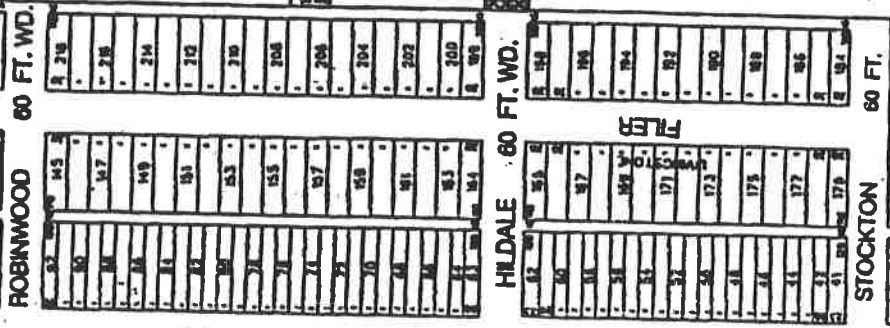
