EnviroSolutions, Inc. (EnviroSolutions) submits this petition request to install permanent monitoring wells within the Huntington Road Right-of-Way (ROW) in the City of Detroit. Specifically, the proposed permit area is the east and west Huntington Road ROW located south of West Seven Mile Road and north of Clarita Avenue. This petition request to install permanent monitoring wells is associated with soil and groundwater investigation activities for the Lucky Mini Mart (a Sunoco retail gasoline station) located at 19331 West Seven Mile Road.

EnviroSolutions proposes to install 3 permanent monitoring wells at the locations shown on the attached Sheet 1. The monitoring wells will be installed using a hand auger and will be completed with flush-mount iron covers and concrete at the surface. The surrounding surface will be restored to the original condition upon completion of the work (topsoil/grass). After installation is complete, EnviroSolutions will access the monitoring wells as needed (activities conducted at each well may include: survey casing elevations, measure depth to groundwater, collect groundwater samples, etc.).

EnviroSolutions anticipates it will take 1 day to complete the work described above. EnviroSolutions expects to conduct the work between 8:00 AM and 6:00 PM and will not conduct work on Saturdays, Sundays or Federal Holidays.




Sheet 1 - Proposed Monitoring Well Location Map
