On Monday, April 11, 2016, I received Petition #1030, I was also instructed by Sargent Marian Champion of the Fourth Precinct to check the neighboring location to get feedback from the citizens and place their information in my response. The petitioner, Emanuel Z. Manos of the Detroit Salt Company, stated they would like to propose a vacation of property. The location is Dunkirk Avenue between Sanders Avenue and the Wabash Rail Road tracks.

On Tuesday, April 12, 2016, at approximately 3:00 PM, I canvassed the location and found three residential homes within the area that appear to be vacant. I then made the location of 12841 Sanders, The Detroit Salt Company and talked to George L Davis, the manager of this location, (313) 841-5144, who stated that, his business owns the property next to the location of the propose change. He also stated that the buildings and residential homes in this area are vacant and they will not be affected by the proposed change. I also talked to Thomas Gutenschwager, (313) 468-4546, former owner of the existing properties on the first block of Dumfries Avenue. He stated that he sold all his properties to the Detroit Salt Company.

My investigation revealed that there were no operating businesses in the surrounding area. The property and residential homes next to the proposed location was recently purchased by the Detroit Salt Company and the propose change will not affect the services provided by the Detroit Police Department. I recommend that petition #1030 be approved as long as access is allowed for emergency services.


