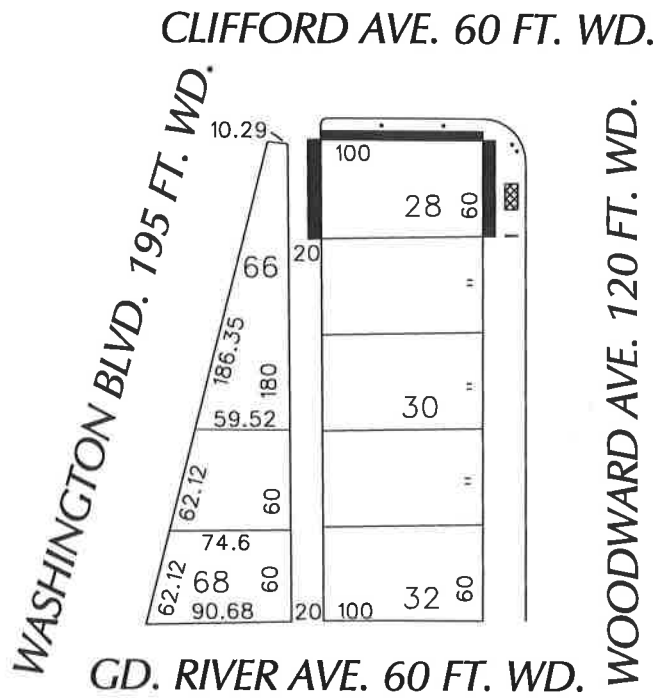
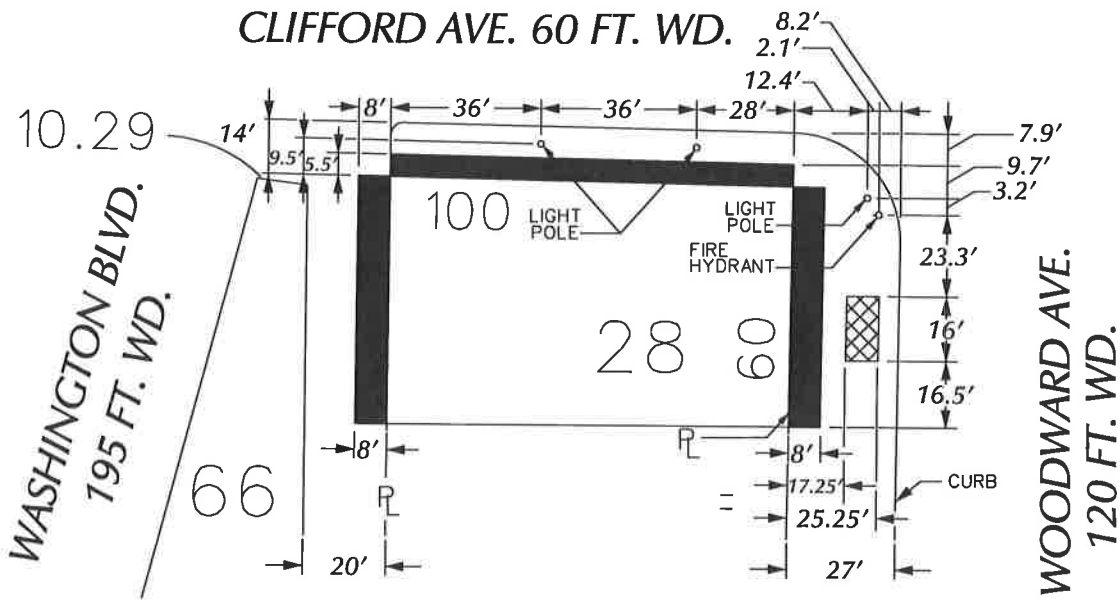
1 CLIFFORD SECTION VIEW
