Honorable Detroit City Council,

This letter is to request the formal closure of an alley extension of Brace Street which is in an industrial area northwest of Fitzpatrick Street, Detroit , MI 48228. This alley extension is unpaved and has two adjacent industrial buildings located at 18700 Fitzpatrick and 18666 Fitzpatrick . At the northern end of the Brace Street extension there is an active railway track owned by the CSX Corporation. Based on Google maps the extension is located at latitude and longitude coordinates 42369146 and 83223465.

In the past this location was a site in which trash and numerous stolen cars were regularly dumped. At the suggestion of Detroit Police Department Environmental Officer Randy Coleman a fence with a gate was installed with the concurrence of the owner of the adjacent property Mr. Cass Cislo. This was done in 1997 and has been in place since that date. The problems of stolen vehicles and trash dumping on the Brace Street extension alley have ceased. Bodywerks, Inc. was not aware that formal City Council was required as we have now been informed by the Detroit Department of Public Works. We therefore are respectfully requesting City Council approval to formally close the Brace Street Extension.

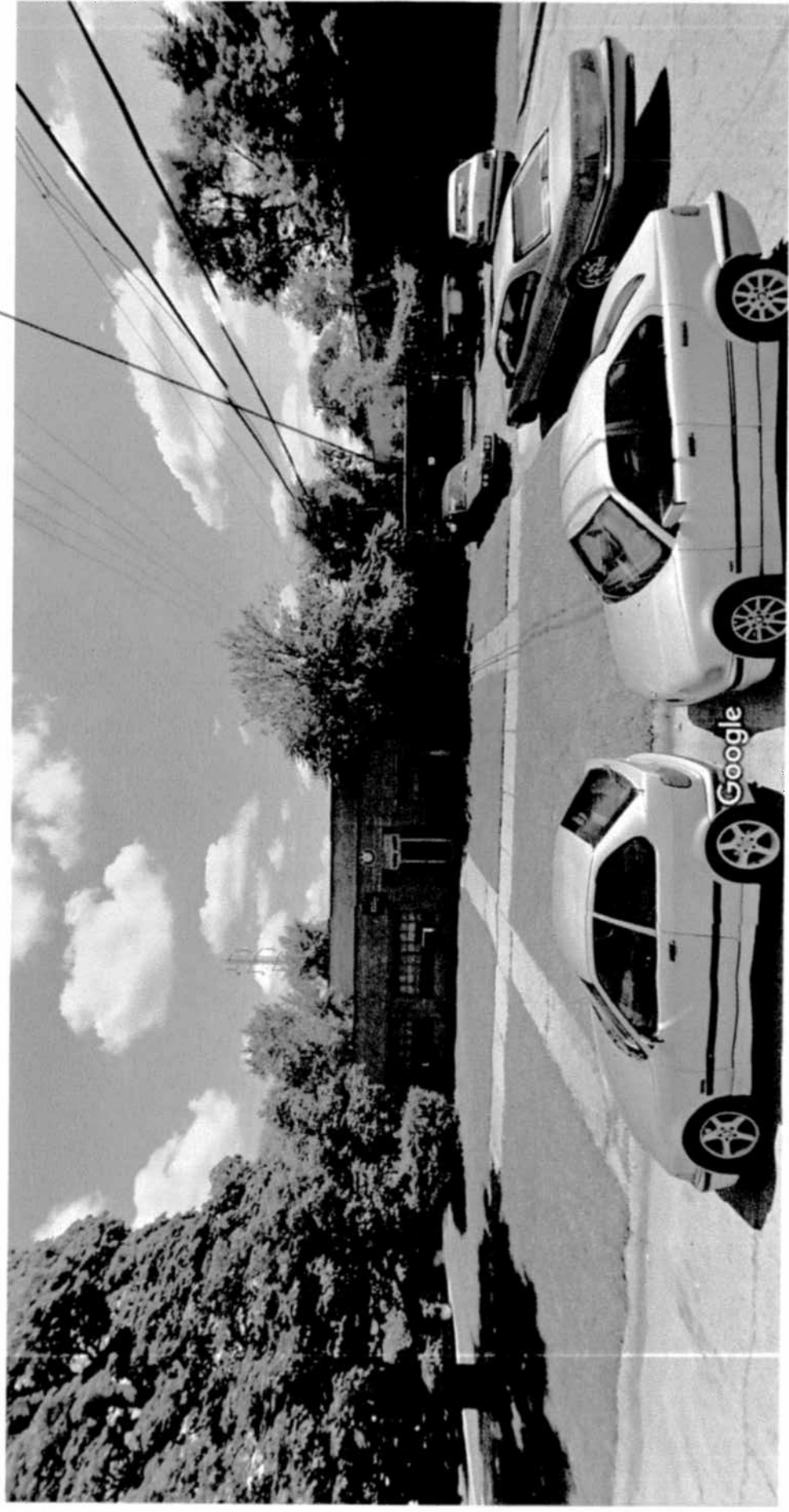


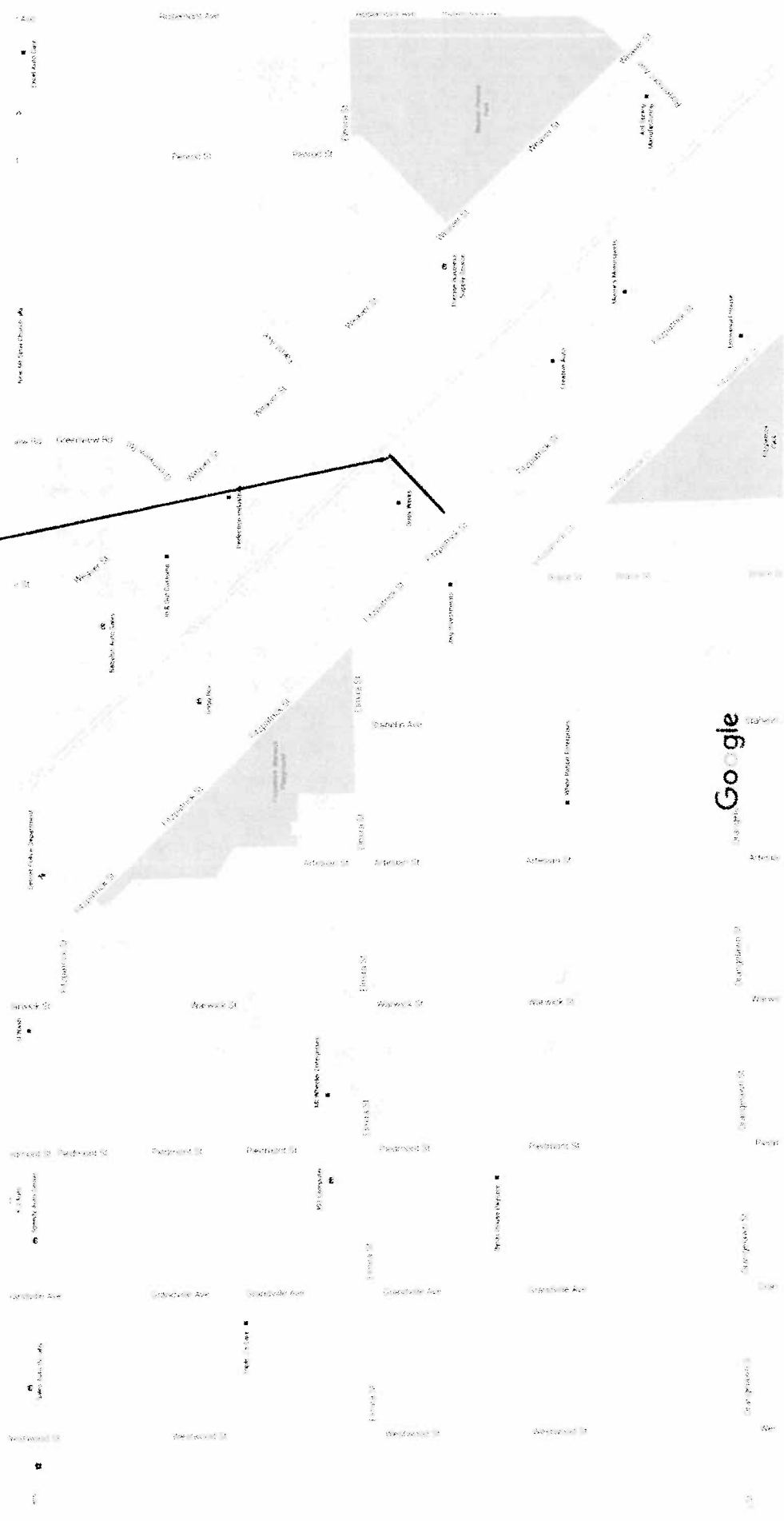
