Mr. Doherty:

Thank you the opportunity to provide comments on Petition #525, 526, 527, 528, and #1772 on behalf of the Downtown Detroit Partnership. We have reviewed this request for an encroachment into the Griswold right-of-way which is adjacent to Capitol Park, a City of Detroit-owned park that we manage under a long-term management agreement.

Upon reviewing the request, we see that the Griswold Street right of way is both in text and in drawings is represented as 60 feet wide from facade of the buildings to the Capitol Park perimeter. We believe this to be inaccurate. The actual distance from the building facades on the west side of Shelby to the edge of the park is 38 feet wide both before and after the planned renovation to the park. We request this information to be reconciled in all permit requests to the City. This still allows for the requested 18' cafe encroachment and a 20' emergency access lane which we support.

We also know that the work outlined in these petitions has already begun without a permit. We respectfully ask that the right of way and any modifications to the edge of Capitol Park be returned to its original condition before any other work is permitted.
