RE: Request for Vacation and Conversion to Easement of Alley

Dear Mr. Gilbert,

It is hereby requested that the city of Detroit vacate the city owned alley on the south side of Baltimore Street, between John R and Brush Streets, Detroit, MI 48202, as well as the current dedicated alley. A survey, exact legal descriptions and parcel maps are provided in Exhibit A attached to this letter. This area contains twenty-one (21) platted parcels, and approximately two acres of land. In addition, this entity and other affiliated entities contain ownership of over 86% of the land in this area. I have attached both the Patrick McGinnis subdivision plat map, and two surveys of this land as Exhibit A to this letter.

The purpose of the request for the vacation and conversion to easement is to provide the development parcels with sufficient area to include both developmental density, parking and landscaping buffers between adjacent parcels and the railroad line to the south. Indicated in preliminary site plan attached as Exhibit B for 248 East Baltimore LLC, which has not yet been approved, the proposed uses for the easement are landscaping and parking.

All remaining parcel owners, as well as the railroad, have been contacted regarding the proposed all vacation.



S Baltimore 90-111 Patrick Mc Ginnis L4 P93 Plats, W C R 1/97




P. MCGINNIS SUB



Resolved That all that part of the east-west public alley 20 feet wide east of John R Street and north of Patience Avenue as platted in Patrick McGinnis Subdivision of Lots 1, 2, 3, 4, 5, 6, 7, 8 and 9 of McCune Subdivision of Part of Fractional Section 21 in the City of Detroit, Wayne County, Michigan as recorded in Liber 4 Page 91 of Plat Wayne County Records, lying south of and adjoining the south line of Lots 92 to 95 both inclusive and south of and adjoining the south line of the west 20 feet of Lot 96, all of the above-mentioned subdivision.

Also all that part of Lots 92 and 93 of the last mentioned Patrick McGinnis Subdivision which was condemned by the City of Detroit for alley purposes on May 31, 1912, J.C.C. Page 534 and 535, being more particularly described as the south 10 feet of Lot 92 and the north 10 feet of the west 15 feet of Lot 93, of the above-mentioned subdivision.

Be and the same is hereby vacated as a public alley to become a part and parcel of the adjoining property subject to the following provisions:

It is provided, That by reason of the vacation of the above-described alley, the City of Detroit does not waive any rights to the sewer located therein and at all times shall have the right to enter upon the premises, if found necessary, on account of said sewer to repair, alter, or service same, and further

It is provided, That if a building is to be constructed over said sewer, the sewer shall be repaired with cast iron pipe of the same size required or increased in 4 inches of Class "A" concrete, or in lieu of the above, such work shall be done as will be specified by the City Engineer, all of the work mentioned to be done under the supervision and inspection of the Department of Public Works and all costs entailed, to be borne by the petitioner, their successors, or assigns, and further

It is provided, That no buildings shall be constructed over said sewer without the prior approval of such building construction by the City Engineer and the Department of Buildings and Safety Engineering, and further

It is provided, That in the event that the sewer located in said alley, if built upon, shall break causing damage to any construction above, the petitioner and their assigns, by acceptance of the permit for building over said sewer, waive all claims for damages to such construction and agree to pay all costs incident to the repair of said broken sewer, and further

Resolved, That the Warranty Deed of Fredson H. Adler and Irene J. Adler, his wife, to the City of Detroit, conveying land for alley purposes, said land being described as "The east 20 feet of Lot 100 of Patrick McGinnis Subdivision of Lots 1, 2, 3, 4, 5, 6, 7, 8 and 9 of McCune Subdivision of Part of Fractional Section 21 of the City of Detroit, Wayne County Michigan as recorded in Liber 4, Page 91 of Plat Wayne County Records" be and the same is hereby accepted and the City Controller is hereby directed to record said deed in the Office of the Register of Deeds for Wayne County.
