Hi Walter,

Just called your office, but I think you're gone for the day. Touching base with you after our call this morning. Gary Wozniak will reach out to Peacemakers to obtain a signature. It has taken us years to get to the point which we're at with Peacemakers as it is. We've certainly had hiccups, but their organization is relatively slow to move. Additionally, only one individual associated with them can sign documents.

Like I mentioned before, we are in the process of obtaining the property involved in this petition. I am again including Matt Walters in this thread so that he might be able to validate the agreement we have made between RecoveryPark, the DLBA, and Peacemakers. I believe an agreement has been made between the three entities, and the property is soon to transfer ownership to us.

I will check back in with Gary when he is here tomorrow to see what progress has been made and will reach back out to you.
