Honorable City Council:

I am writing with a request to vacate an alleyway adjacent to two parcels of property we currently own and control one block south of East Grand Boulevard in the North End neighborhood. Please find details of the request below:

- WHO: Rusas Owner LLC is the petitioner and current property owner adjacent to the alley. We currently maintain all aspects of the alley, which includes landscaping, snow removal, and concrete repairs.
- WHAT: We are requesting a vacation of the alleyway that will allow for the ability to build over the right of way at a future date.
- WHERE: The alleyway is generally bound by East Grand Boulevard to the north, East Milwaukee to the south, Oakland Avenue to the east, and Saint Antoine to the west. More specifically, the alley is located directly south of 6540 Saint Antoine (tax id: 003271) and 6527 Oakland (tax id: 003024).
- WHEN: We are requesting to start the process towards vacation of the alley as of today, November 4, 2016.
- WHY: We are requesting the alley to be vacated for the following reasons:
 - No pedestrians or vehicles currently use the alley as a right of way. The
 alley is currently used for parking by the small businesses located at 6540
 Saint Antoine. The previous owner for similar reasons vacated the alley
 perpendicular to the subject alley.
 - As the property owner, we are incurring the expense of the upkeep and management of the alleyway.
 - It will help to encourage future development on the property, which will be beneficial for a neighborhood with several vacant and blighted properties.
