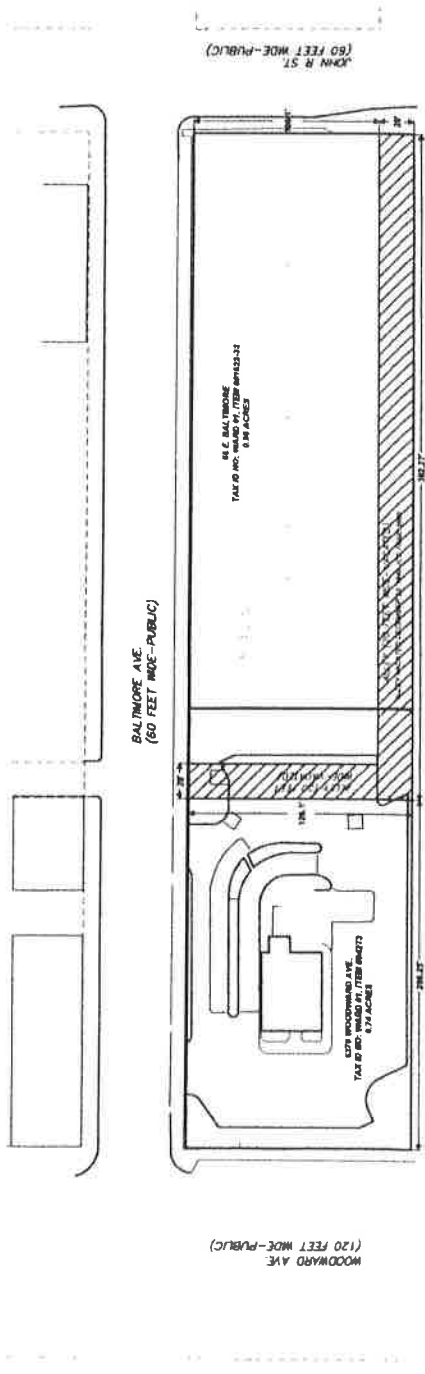
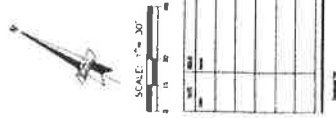

Dear Honorable City Council:

Vanguard Community Development Corporation (Vanguard) was founded in 1994 by Bishop Edgar Vann, II, to facilitate the revitalization of the physical, social, and economic fabric of The North End and to increase expectations and expand the possibilities envisioned for the neighborhood after decades of disinvestment. Vanguard CDC has served over 100,000 families and invested more than \$60,000,000 in Detroit through programs and development since 1994. Vanguard is renovating an existing 7,000 square foot building into a 10,000 square foot building for Goodwill Industries' "Flip The Script" Program. Along with the 3,000 square foot addition of the building for this project, we will be building a parking lot on top of a vacated easement at the South Side of the property. Therefore, we are filing a petition with City of Detroit to encroach upon this easement which a storm drainage pipe below. Vanguard understands that if a problem arises with the public utilities within the site's limitations, the City will have all rights to repair without permission from us.

Our site is located at 2777 E. Grand Blvd, two buildings down from Vanguard's home office. We have attached a site plan and site location of the area.

Construction of the Goodwill Project began February 1, 2016, and will be completed by August 15, 2016.

Vanguard is requesting the right to encroach upon the vacated alley to create the necessary secured parking for the employees and daily visitors. The petition is required in order for the site utility contractor and plumber to pull the necessary permits to work safely on the site.

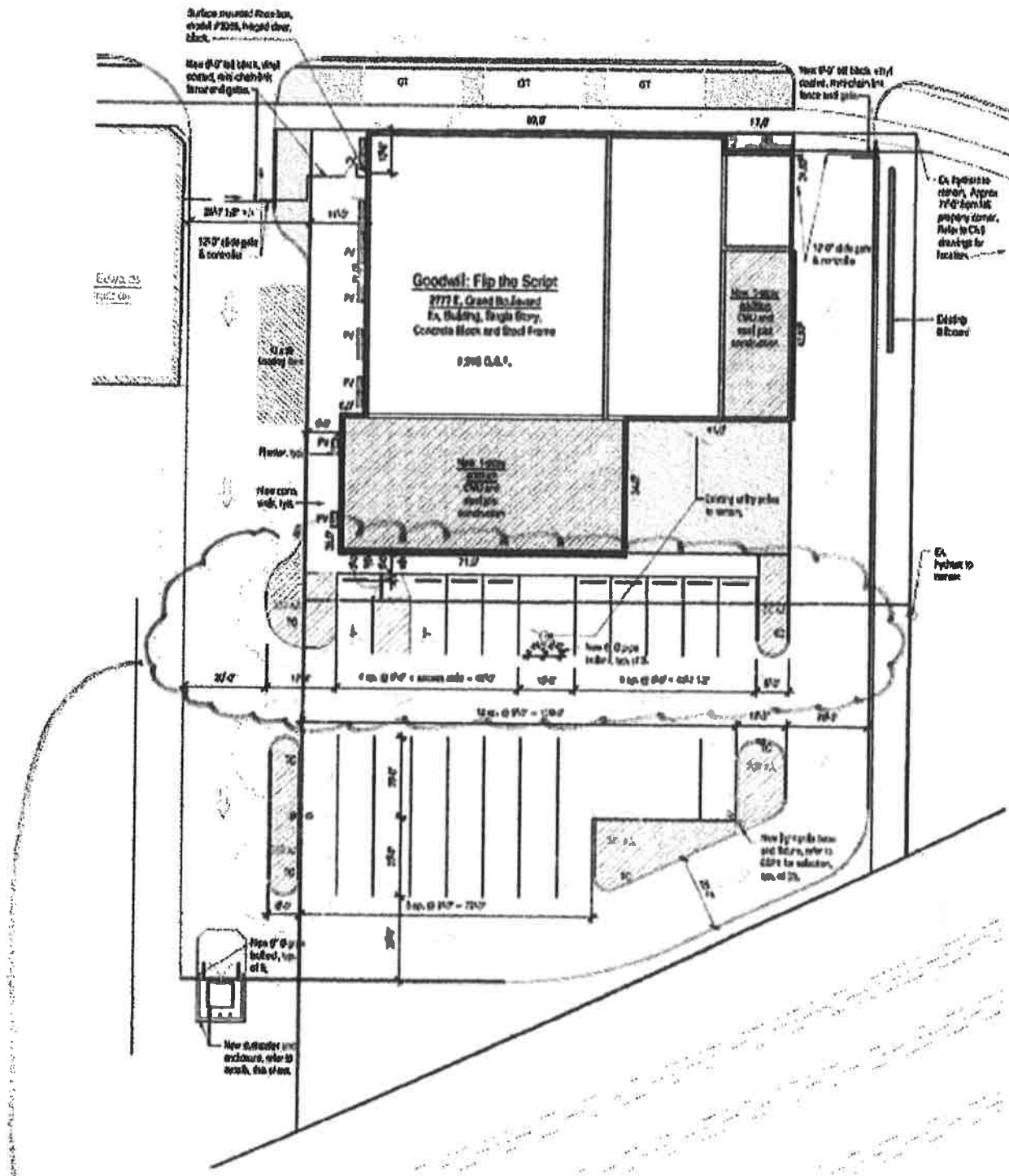
