

Vanguard Community Development Corporation (Vanguard) was founded in 1994 by Bishop Edgar Vann, II, to facilitate the revitalization of the physical, social, and economic fabric of The North End and to increase expectations and expand the possibilities envisioned for the neighborhood after decades of disinvestment. 




