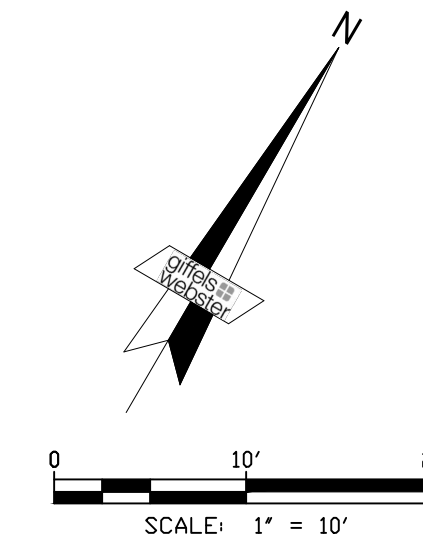




LOCATION MAP

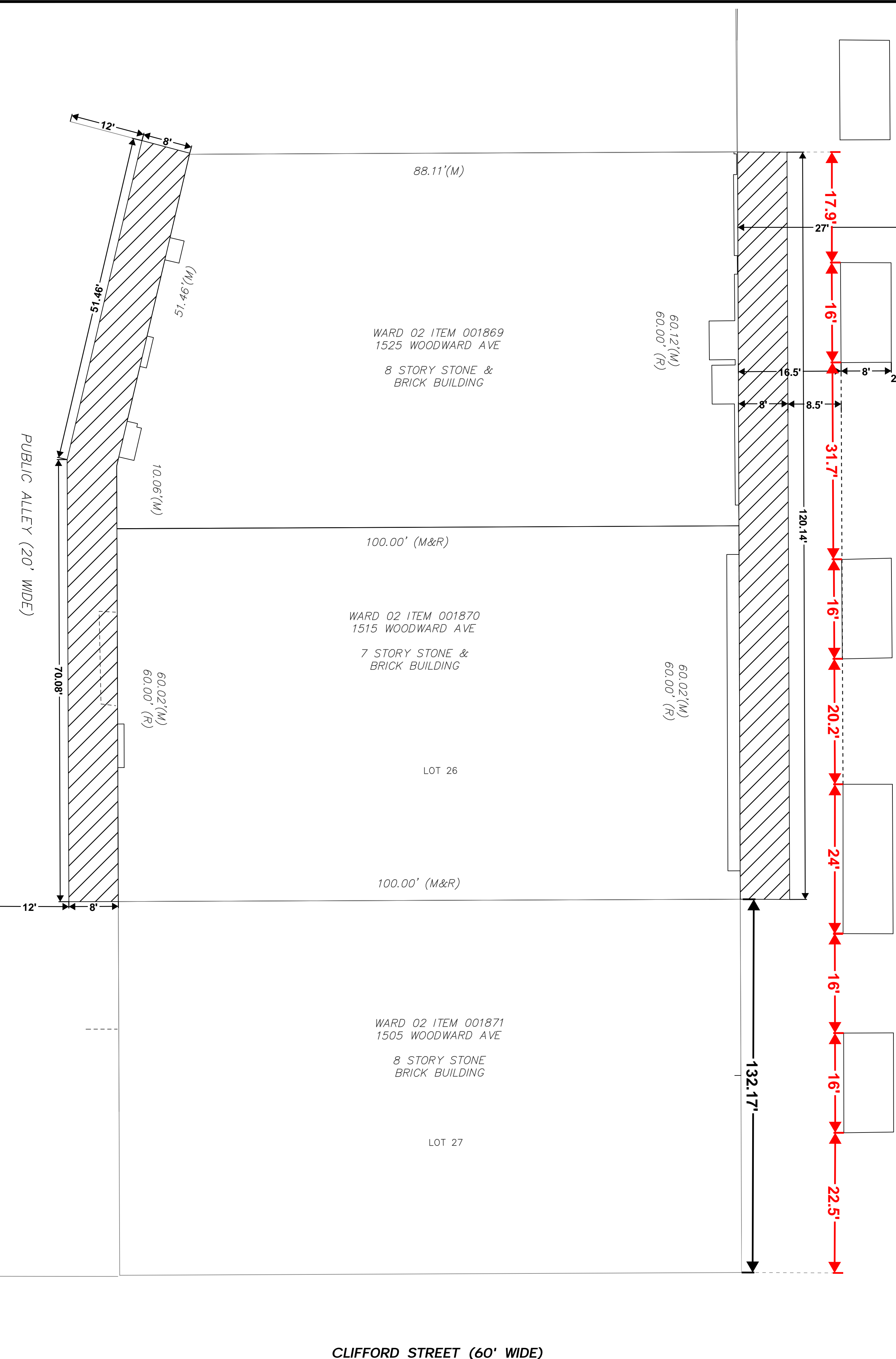
