At 12:00 PM, on the above date I made the location of 6362 Michigan Ave., Georges Coney Restaurant, and spoke with Beverly Wallace (owner), 313-778-6339, who stated, with this proposed closure she would still be able to access the rear of her business and it would in no way effect the performance of her establishment. The homes and businesses located on Gilbert Street and Livernois Street will not be affected by this proposed change. This property change would not affect police services or emergency services to the residents or businesses in the area. Therefore, I recommend petition X1361 is approved.

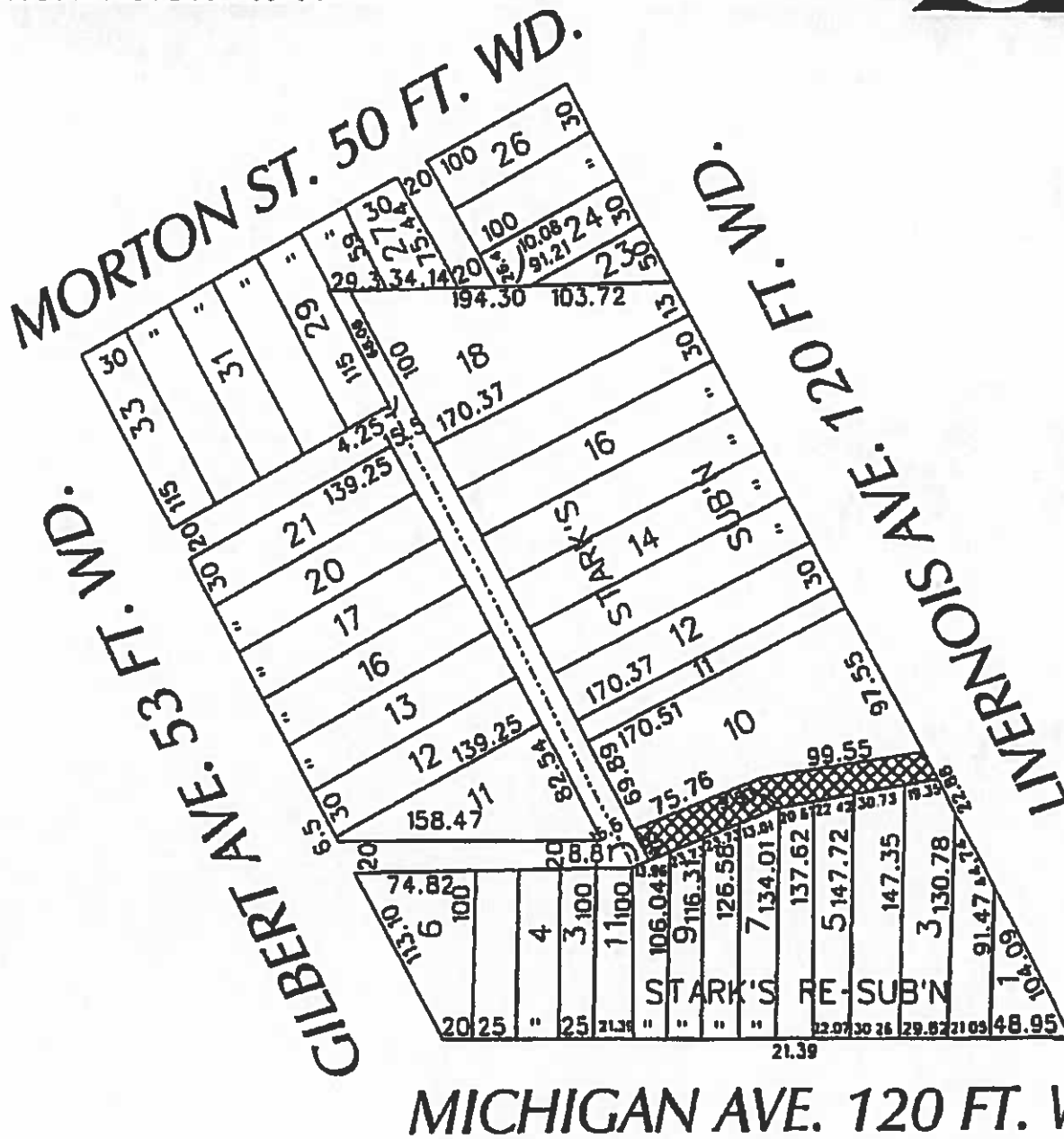
