On Friday, February 10, 2017, I received Petition #1406. I was also instructed to investigate the petition by the due date and report recommendations. The petitioner, Jennifer Boueri Chilson of the Dykema Gossett Company, stated they would like to propose an outright vacation of property. The location of this property is Barnes Street between West End Ave. and the Wabash Rail Road tracks, also known as the Zug Island Private Road.

On Monday, February 13, 2017, at approximately 11:00 AM, I canvassed the location and found no residential homes within the area. I then made the location of 7891 Medina Street, and talked to Ms. Dorothy Rodgers, a home owner that lives one block over from the proposed location, (313) 841-9727, who stated that access to this area is not need by the residents of Medina Street.

My investigation revealed that there were no operating businesses located in the surrounding area. The property next to this location is completely vacant with no existing structures and the proposed change will not affect the services provided by the Detroit Police Department.
