
Re: Petition of encroachment

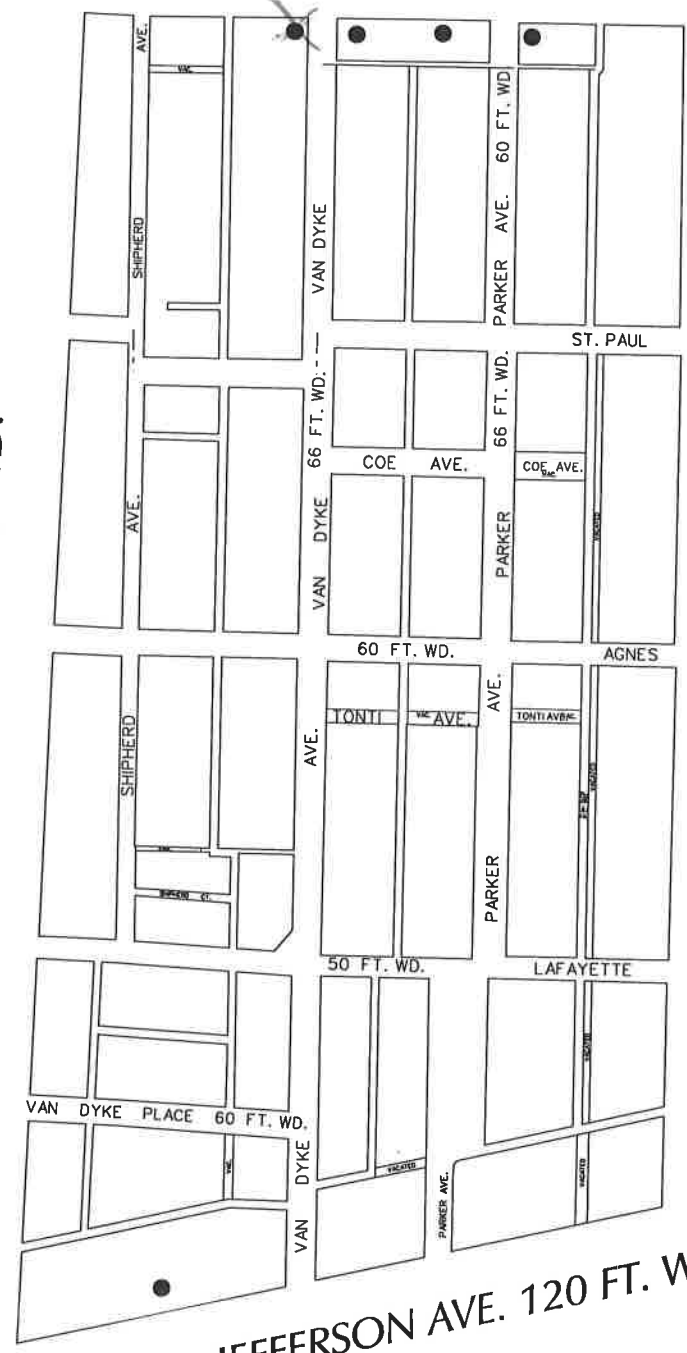
