On behalf of the U.S. Coast Guard ("USCG"), we are writing to give notice to and request your consent to the conversion to easement of a certain portion of Mount Elliot Street lying south of Wight Street (the "Conversion to Easement"). The proposed converted portion of Mount Elliot Street is noted on the enclosed survey. If the Conversion to Easement is approved, the identified area would become private property, however, the USCG would not be allowed to build over the area. Further, all currently existing utilities would remain in the area and access to those utilities would be maintained. This Conversion to Easement will neither substantially impede pedestrian or vehicular traffic as this portion of the street has no outlets and dead ends at the parking lot of 110 Mt Elliott St., which is currently a USCG station. The Conversion to Easement would result in enhanced facilities and operations at the existing USCG station.


