The petition was referred to the City Engineering Division – DPW for investigation (utility review) and report. This is our report.

After reviewing the petitioner's request it was determined that the petitioner, The Joseph Dedvukaj Firm, P.C., has petitioned to vacate the east-west segment of the public alley adjacent to 17376 Schaefer Hwy. for reasons of improving security to the property. At this time petitioner has not demonstrated any immediate need for the vacation to occur by way of development or land improvement. The act of vacating the proposed alley proves to be an excessive measure for the reasons provided. It is the opinion of the City Engineering Division that the east-west segment of the public alley adjacent to 17376 Schaefer Hwy. remain accessible and open for public use.


