RE: Giffels Webster - Request for encroachments into Trumbull Avenue

Giffels Webster, 28 W. Adams, Suite 1200, Detroit, Michigan 48226, on behalf of The Corner, 1620 Michigan Avenue Detroit, MI 48202, respectfully requests to encroach into Trumbull Avenue right-of-way with the installation of landscaping planters, one private light pole, bike racks, benches, a screen wall and decorative pavement.

We are requesting the following encroachments:

- One encroachment along Trumbull Avenue right-of-way for a landscape area, which shall be 121.4 feet in length and 11.2 feet in width;
- One encroachment into Trumbull Avenue right-of-way for a private light pole in the 1.8 foot landscape area between the right-of-way and the screen wall.
- One encroachment into Trumbull Avenue right-of-way for a masonry parking lot screen wall that is 120.4 feet long, 1 foot wide and 6 feet tall.
- Six encroachments into Trumbull Avenue right-of-way for bike racks;
- Four encroachments into the Trumbull Avenue right-of-way for tree grates, each of which shall be 14.5 feet in length, 6 feet in width;
- Six encroachments into the Trumbull Avenue right-of-way for L-shaped benches, each of which will be 8.7 x 1.9 feet long and 6 feet by 1.25 feet wide;
- One encroachment on into the Trumbull Avenue in the right-of-way at the intersection with Michigan Avenue for brick pavers for the full extent of the sidewalk expanding about 46 feet north;

These encroachments will neither impede pedestrian nor vehicular traffic, nor will they interfere with the maintenance of the public rights-of-way, including utility company and Fire Department access. The requested encroachment maintains, at minimum, a 6.0 foot wide access way within the sidewalk for pedestrian use.

In addition to these encroachments, we are requesting the establishment of a maintenance and indemnification agreement for all of the items listed above.


