Re: 2457 Beaubien St – Request to Vacate a Portion of 2457 Beaubien St for the Widening/Reconnection of the Fisher Freeway Service Drive

The Planning and Development Department respectfully requests that the following portion of 2457 Beaubien St, be dedicated as part of the existing right of way for the expansion of the Fisher Freeway Service Drive between Beaubien and Brush:

**Land for intersection improvement at
East Bound Fisher Service Drive and Beaubien Street**

Land in the City of Detroit, Wayne County, Michigan being part of Lots 10 and 11 and vacated alley adjoining said Lot 10 "Crane and Wesson's Plat of the Subdivision of Outlots Nos. 176 & 178 Lambert Beaubien Farm" as recorded in Liber 37, Page 488 of Deeds, Wayne County Records; and being more particularly described as follows: Commencing at the northeast corner of Lot 14 of the aforementioned "Crane and Wesson's Subdivision"; thence S27°04'30"E along the westerly line of Beaubien Street, 40 feet wide, 146.47 feet to the Point of Beginning; thence S27°04'30"E continuing along the westerly line of Beaubien Street, 45.00 feet; thence S62°51'26"W along the southerly line of said Lot 10 of the aforementioned "Crane and Wesson's Subdivision" 97.00 feet; thence N37°58'55"E 106.98 feet to the Point of Beginning.
