RE: Giffels Webster – Request for a series of vacations and encroachments into of the rights-of-way within the block bounded by Elizabeth Street (60 feet wide), Woodward Avenue (120 feet wide), Adams Avenue (60 feet wide), and Park Avenue (60 feet wide).

Giffels Webster, 28 W. Adams, Suite 1200, Detroit, Michigan 48226 on behalf of Chemical Bank, 2130 W. Big Beaver Rd, Troy, MI 48084, respectfully requests the following vacations and encroachment into the rights-of-way within the block bounded by Elizabeth Street (60 feet wide), Woodward Avenue (120 feet wide), Adams Avenue (60 feet wide) in the City of Detroit:

- An outright vacation, maintaining a pedestrian easement with support columns extending 5.0 feet into the Elizabeth Street (60 feet wide) right-of-way, beginning at the eastern corner of the property, extending 220.4 feet west. This easement will begin at grade and extend 10.0 feet above grade.
- An above grade encroachment extending an additional 5 feet into the Elizabeth Street (60 feet wide) right-of-way, starting 5.0 feet inside the right-of-way, beginning at the eastern corner of the property, extending 220.4 feet west. This encroachment will begin 10.0 feet above grade and extend to 285.0 feet above grade.
- An above grade outright vacation extending 5.0 feet into the public alley (20 feet wide) right-of-way. The outright vacation would begin 94.8 feet west of the Woodward Avenue (120 feet wide) right-of-way and continue 120.0 feet west. It would start 40.0 feet above grade and extend to 285.0 feet above grade.

The requested vacations and encroachment are a critical part of the Chemical Bank Headquarters project. Please refer to the attached detailed sketches for further clarification.


