RE: Giffels Webster – Requests several vacations of public alleys.

Giffels Webster, 28 W. Adams, Suite 1200, Detroit, Michigan 48226 on behalf of Leland House, owner of 400 Bagley Street, Detroit, Michigan 48226, respectfully requests the outright vacation (with no easement retained) of two existing public alleys, one 20 feet wide and one 15 feet wide, bounded by Bagley Street (90 feet wide), Cass Avenue (60 feet wide), Plaza Drive (40 feet wide), First Street (60 feet wide). We also are requesting the outright vacation of all easements and other rights of three previously vacated public alleys, all 15 feet wide. Descriptions of the public alleys are as follows:

- Request the outright vacation (with no easement retained) of the existing 20 foot wide alley abutting Lot 17 and the south 20 feet of Lot 18, Block 54 of Cass Western Addition to the City of Detroit, according to the plat thereof as recorded in Liber 42 of Deeds, pages 138-141, Wayne County Records.
- Request the outright vacation (with no easement retained) of the existing 15 foot wide alley abutting Lots 13-17 and a portion of Lot 10, Block 54 of Cass Western Addition to the City of Detroit, according to the plat thereof as recorded in Liber 42 of Deeds, pages 138-141, Wayne County Records.
- Request the outright vacation of all easements and related rights to all other previously vacated public alleys within the block bounded by bounded by Bagley Street (90 feet wide), Cass Avenue (60 feet wide), Plaza Drive (40 feet wide), First Street (60 feet wide).

The outright vacation of these public alleys is necessary for the redevelopment of the site. Limits of the requested vacations can be found in the attachment, enclosed herein.
