Petition No. 1103 of "Scott D. Lowell" request to vacate and convert to easement the alley bounded by Marantette Street, 14th Street, Dalzelle Street, and Wabash Street.

The petition was referred to the City Engineering Division – DPW for investigation (utility review) and report. This is our report.

After reviewing the petitioner's request, it was determined that the alley is in use by a residential occupant located off of Wabash Street. The residential property is designed with the garage orientated toward the alley for rear vehicular access. The alternative solution of creating a private easement for the residential occupant was proposed. The majority of the block will have a single title holder and the residential occupant is the only resident on the block. Proof of a private easement for the resident would resolve the issue of rear access. Petition x1103 was submit on Sept 26th, 2019. The petitioner was notified of the access issue and provided options for resolve. At this time no decision has been made for a resolution. This petition has remained inactive for a period longer than 12 months.
