RE: Petition for Encroachment on Right of Way

Infinity Technology Group (ITG) has been contracted by Integrated Manufacturing & Assemblies to install an underground fiber optic cable between two buildings; 6555 E. Davison and 6501 Nevada.

The fiber optic cable will be placed in a 1.25" non-metallic conduit buried in the utility easement between the sidewalk and the street. The path will originate from the southeast corner of the 6501 Nevada property. It will go east along Nevada and then cross under Nevada and head south at the intersection of Sherwood. The path will then continue south on the west side of Sherwood and then enter the Northeast corner of the IMA 6555 E Davison property.

The conduit will be placed using Horizontal Directional Drilling. This construction method involves the controlled directional drilling of a pilot bore/hole, back reaming/hole, enlargement (if required) and pull back of 1.25" polyethylene pipe. The drilling process utilizes drill pipes, drill bits and reamers in conjunction with an engineered drilling fluid solution. Underground depth is designed at 48" but can be adjusted if requested by other utilities.
