Hi Keith,

Per our phone conversation this morning I've confirmed that all of the dimension in the sketch provided are correct. Attached below is a write up per our conversation.

- An encroachment extending 172.1 feet along Second Avenue (150 feet wide) sidewalk for non-standard items (including walls, foundations, non-standard walks, trees, tree grates, monuments, etc.), all of which will be maintained by Pistons Performance LLC. This encroachment area will extend 21.7 feet into the Second Avenue right-of-way.
- An 8.0-foot-wide above grade pedestrian easement in the sidewalk along Amsterdam Street (50 feet wide). This easement area will extend 334.0 feet along Amsterdam Street.
