RE: Giffels Webster – Request for a series of vacations and encroachments into of the rights-of-way within the block bounded by Amsterdam Street (50 feet wide), Second Avenue (150 feet wide), Third Street (variable width), and Baltimore Street (60 feet wide).

Giffels Webster, 28 W. Adams, Suite 1200, Detroit, Michigan 48226 on behalf of Henry Ford Health Systems, One Ford Place, Suite 4A, Detroit, MI 48202, respectfully requests the following vacations and encroachment into the rights-of-way within the block bounded by Amsterdam Street (50 feet wide), Second Avenue (150 feet wide), Third Street (variable width), and Baltimore Street (60 feet wide) in the City of Detroit:

- An above grade encroachment extending 129.0 feet along Second Avenue (150 feet wide) sidewalk for stairs, ramps, and a wall.
- An above grade CED indemnification area that extends 174.9 feet in the sidewalk along Second Avenue (150 feet wide) for maintenance of non-standard items to accommodate decorative plaques in the pavement, monuments and their foundations, etc., all of which will be maintained by Pistons Performance LLC. This CED indemnification area will extend 29.1 feet into the Second Avenue right-of-way.
- An above grade encroachment in the sidewalk along Second Avenue (150 feet wide) for monuments, decorative plaques, tree grates, etc. This encroachment area will extend 82.3 feet along Second Avenue.

The requested vacations and encroachments are critical for the streetscape improvements for the Pistons Performance Facility project. Please refer to the attached detailed sketches for further clarification.






