On Wednesday, November 13, 2019, I received Petition X 723. I was also instructed to investigate the petition by the due date and report recommendations. The petitioner, Mr. Mark Fraser of 1378 Woodbridge, stated he would like to outright vacate Springwells Avenue between Michigan Avenue and Edsel Ford Expressway and the public alley behind 7900 Michigan Avenue.

On Thursday, November 14, 2019, at approximately 11:00 AM, I met with the petitioner (Mr. Fraser) and canvassed the area. The petitioner is the owner of Father and Son Muffler Clinic that is located at 7900 Michigan Avenue. Mr. Fraser stated that he would like to close of the rear of his location to keep any illegal activities from occurring. Mr. Fraser further stated that he is not trying to close of Springwells, but rather to have control to maintain the location. Mr. Fraser also stated that the street will be completely accessible to the public.

On Friday, November 15, 2019, at approximately 10:30 a.m., I made the location of 7844 Michigan Avenue (AK Auto Sales) and spoke to the owner Aqil Ahmed, W/M, DOB:12/04/86, telephone number: 313-999-3347. Mr. Ahmed stated that he will be okay with the petition as long as he was able to access his business without any problems.

The conversion to easement would not affect E.M.S, Detroit Fire Department, and the Detroit Police Department, D.T.E. or other businesses in the area.
