Giffels Webster, 28 W. Adams, Suite 1200, Detroit, Michigan 48226 on behalf of Rock Development LLC, 1092 Woodward Avenue, Detroit, Michigan, 48226, respectfully requests that the City of Detroit vacate the following public alley and public easements:

- Outright vacate the public alley (20 feet wide) in the block bounded by Rivard Street (66 feet wide), Hendrie Street (66 feet wide), Russell Street (80 feet wide) and E Ferry Street (60 feet wide).
- Outright vacate the two (2) 6 foot wide public easements in the block bounded by Rivard Street (66 feet wide), Hendrie Street (66 feet wide), Russell Street (80 feet wide) and E Ferry Street (60 feet wide) per Milwaukee urban renewal plat L.89, P.53.
- Outright vacate the 20 foot wide public easement in the block bounded by Rivard Street (66 feet wide), Hendrie Street (66 feet wide), Russell Street (80 feet wide) and E Ferry Street (60 feet wide) per Milwaukee urban renewal plat L.89, P.53.

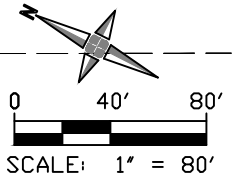
Limits of the requested vacations can be found in the attachment, enclosed herein. These vacations are a part of the Wayne County Justice Complex project.

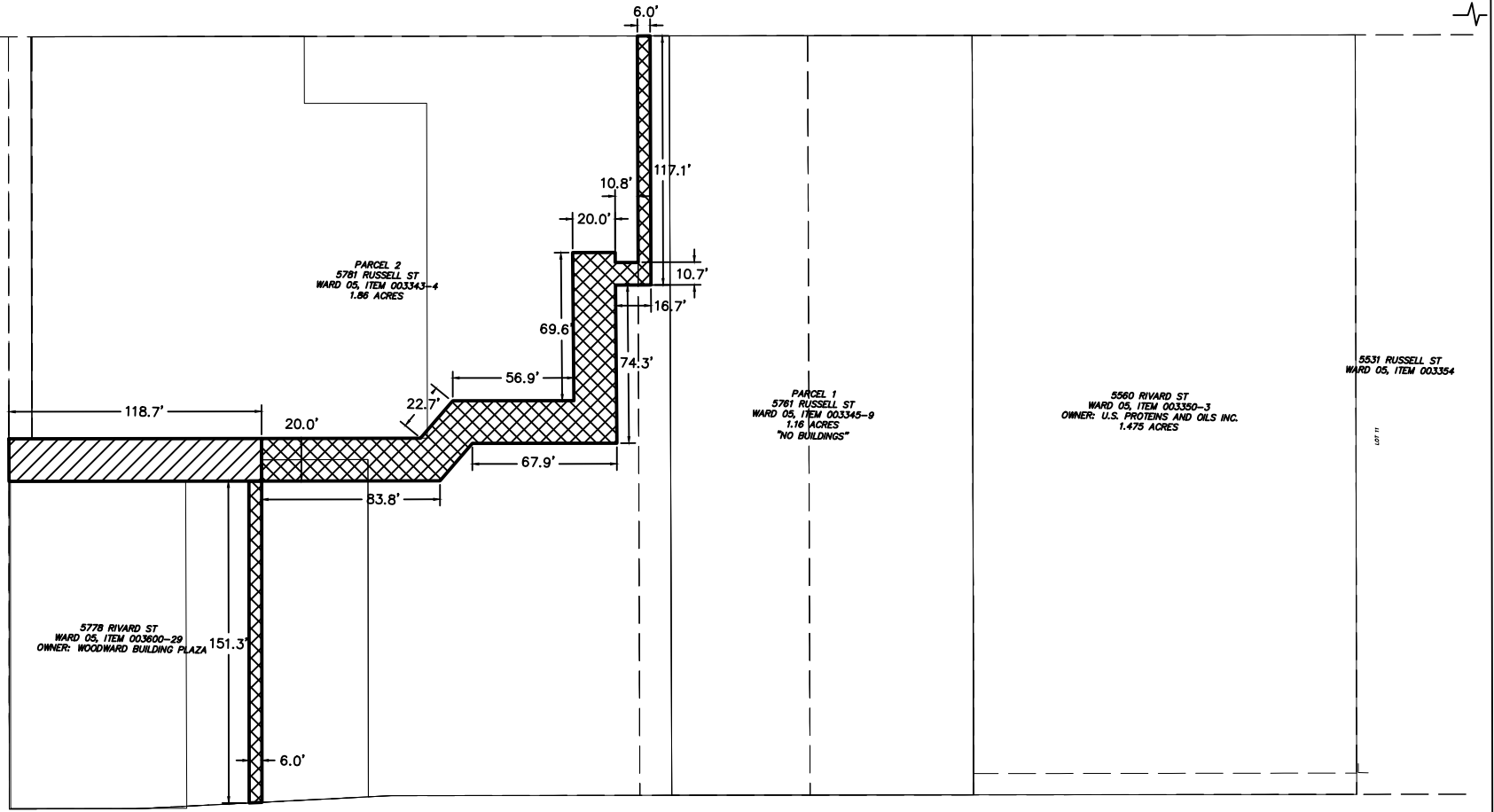


