To whom it may concern, My name is Scott Craig. I live at 446 Marlborough, which I purchased from DLBA as a full rehab. I also own the lots behind my house at 443, 447 and 451 Philip. I'm currently in the process of purchasing 433, 439 and 455 from the city of Detroit/DLBA. I'm also currently in the process of buying the vacant home next-door to me at 450 Marlborough from the City of Detroit P&DD c/o DBA and the privately owned lot next to that at 454 Marlborough.

I'm requesting that the city officially vacate the abandoned alley that runs behind Marlborough St and Philip St, from Essex Ave to Avondale St. This block has very few homes on either street. Roughly 12 occupied homes total and a handful of vacant homes. The alley hasn't been used for a very long time. It is overgrown with trees and has seen massive amounts of illegal dumping. I believe allowing the home owners to take over this land will eliminate the dumping and give the homeowners a reason to keep this land free of trees and brush for utility access. My personal interest revolves around fencing in my adjoining properties to keep the packs of vicious wild dogs off my property. I have children and the wild dogs are a true menace. On top of that people's pets often get loose in this neighborhood, one or more per day as observed on the web app 'Nextdoor' and the pets around here are usually Pitbull or Rottweiler and very aggressive. At the moment I can't even let my children play in my own backyard. It's disheartening to say the least. The illegal dumping has to stop also, without cleaning up the alley and blocking access I'm not sure what to do.




