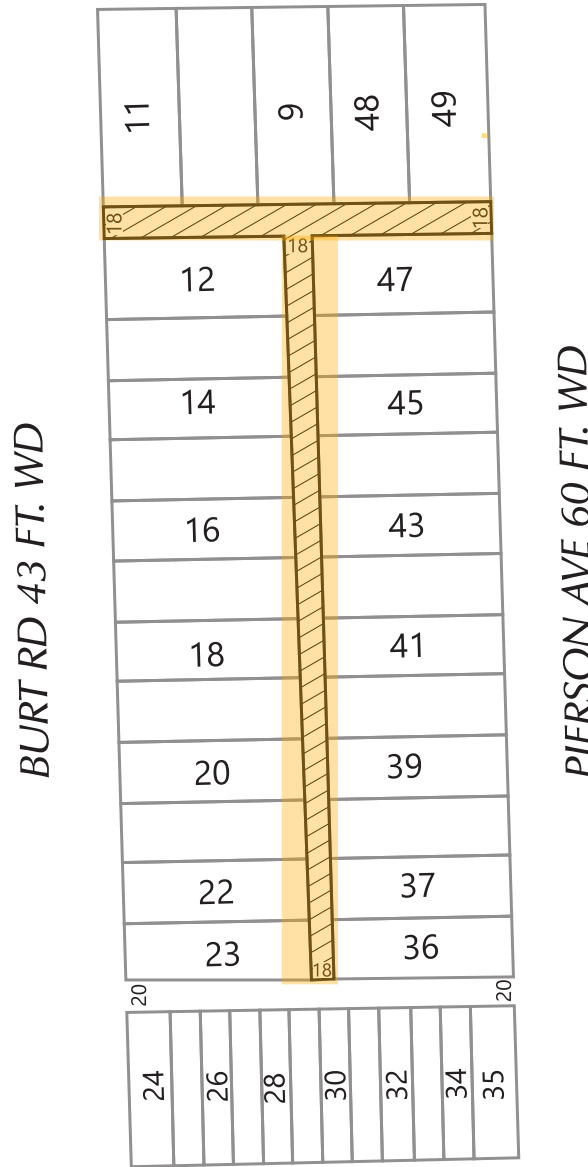

My name is Keith Godley and I am the owner of the property at 9617 Pierson St Detroit MI 48228. On the North side of the property there is an alley way that goes from Pierson St to Burt Rd. Within the past 10 years my garage has been broken into twice, graffiti art has been sprayed on neighbors' garages, and unscrupulous characters have walked up and down the alley way threatening my family with physical violence. My garage opening is the only one that faces the alley. I have maintained the alley way for over 30 years by keeping it clean and cutting the grass.

I am asking the city council for permission to close off the alley way to provide safety and cleanliness for myself and my neighbors. The alley way is no longer in use by the city or state and I have no problem giving utility, cable, or water departments access to the alley way for public work once it becomes my property. In conclusion this should have been done over 30 years ago when the alley was stopped being used for trash pickup. Thank you for your concern on this matter.
