RE: Giffels Webster – Request for below grade encroachments into of the rights-of-way within the block bounded by Michigan Avenue (120 feet wide), Woodward Avenue (120 feet wide), Griswold Street (60 feet wide), and State Street (60 feet wide).

Giffels Webster, 28 W. Adams, Suite 1200, Detroit, Michigan 48226 on behalf of PAPERCLIP PROPERTIES, LLC, 630 Woodward Avenue, Detroit, MI 48226, respectfully requests the following below grade encroachments into the rights-of-way within the block bounded by Michigan Avenue (120 feet wide), Woodward Avenue (120 feet wide), Griswold Street (60 feet wide), and State Street (60 feet wide), in the City of Detroit:

- A below grade encroachment into the 7.9 feet into the State Street (60 feet wide) for an existing underground vault with grates at sidewalk surface. This encroachment begins 1.4 feet east of the eastern Griswold Street (60 feet wide) and extends 81.5 feet east.
- A below grade encroachment into the 10.4 feet into the Griswold Street (60 feet wide) for an existing underground vault with grates at sidewalk surface. This encroachment begins 1.1 feet south of the southern State Street (60 feet wide) and extends 69.8 feet south.

The requested below grade encroachments are a critical part of the David Stott building improvements. Please refer to the attached detailed sketch for further clarification.

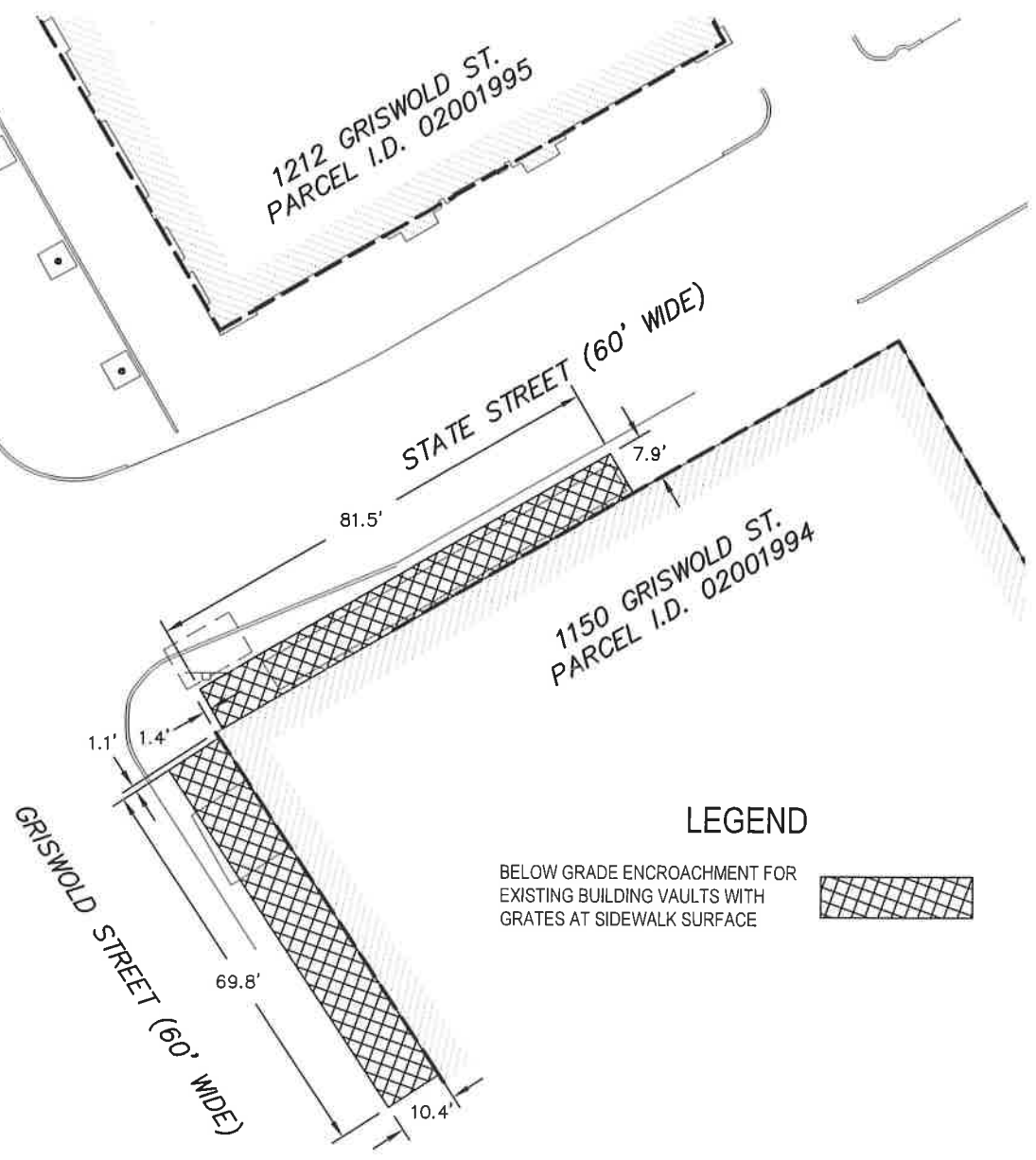
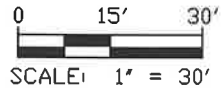
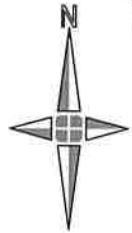

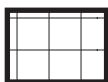
