Dear Sirs or Mesdames:

This firm represents Jefferson Ventures LLC, a Michigan limited liability company that owns the properties at the addresses referred to above. On behalf of our client, we request that the alley located between the southern parts of 2290 E. Jefferson and 301 Chene Street be vacated by the City.

The specific description of the alley subject to this request lies between Lots 1 and 2, Block 4, on the East, and the southerly portion of Lot 8, Block 4, on the West, each in the Subdivision of Part of James Campau Farm, East ½ Private Claim 91 (Blocks 1 through 12, inclusive), as recorded in Liber 2 of Plats, Page 17, Wayne County Records. Essentially, this is the part of the alley that runs from Franklin Street to a line running along the northern boundary of Lot 2, Block 4; the balance of the alley was vacated in 1922. See JCC 1-17-1922, Page 60.

We note that the vacation of this alley also was requested through the submission of a Smartsheet Form, the receipt of which was acknowledged by the City on February 4, 2021. As noted in such request, Jefferson Ventures LLC owns all the surrounding property down to Franklin Street, and the vacation would rationalize (“square off”) the property boundaries and facilitate development. As also noted therein, there is reason to believe that this part of the alley may have been vacated at some point after JCC 1-17-1922, as evidenced by documents of record and the conduct of prior owners. This having been said, Jefferson Ventures LLC would like to have the vacation completed as of record.

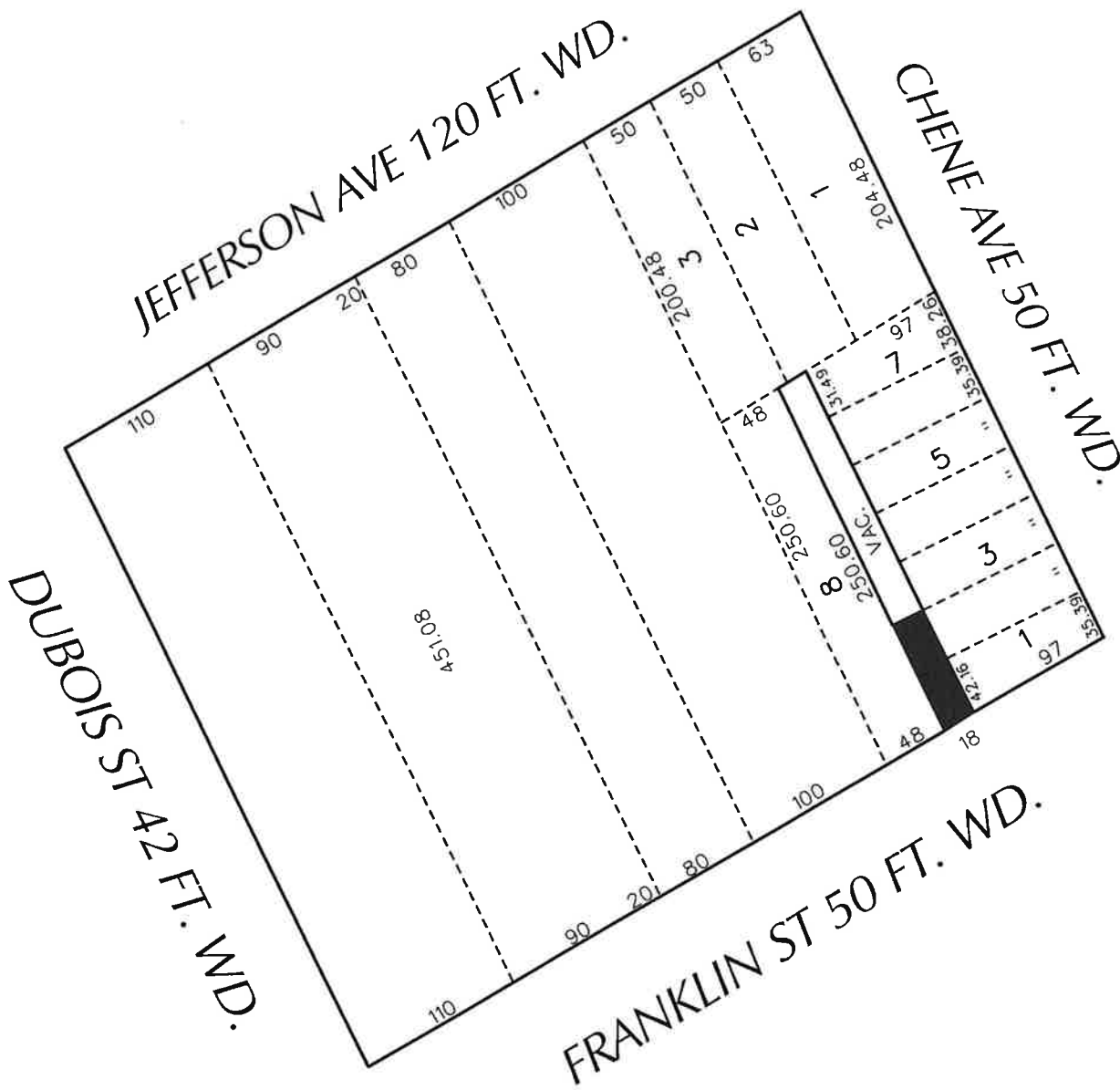
