**Legal Description**

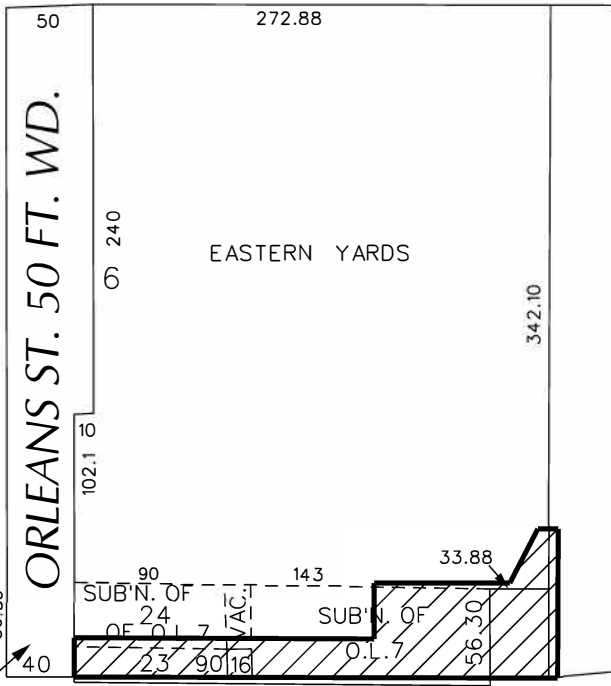

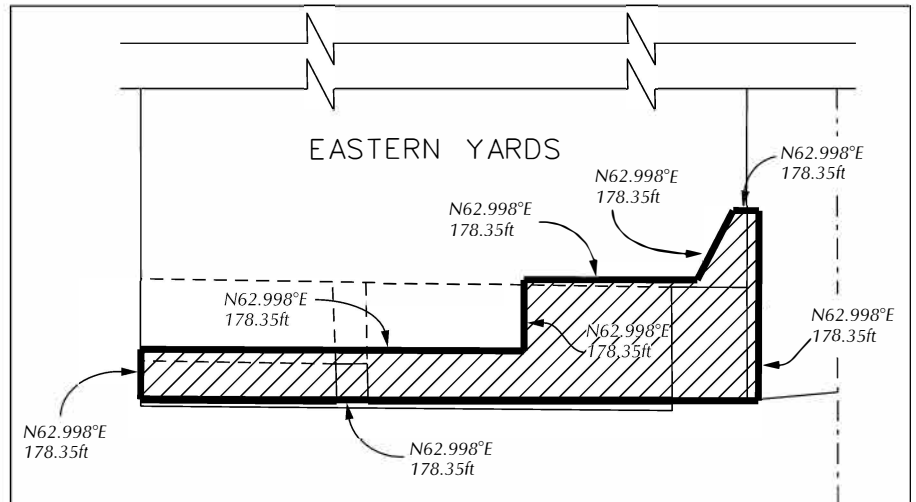

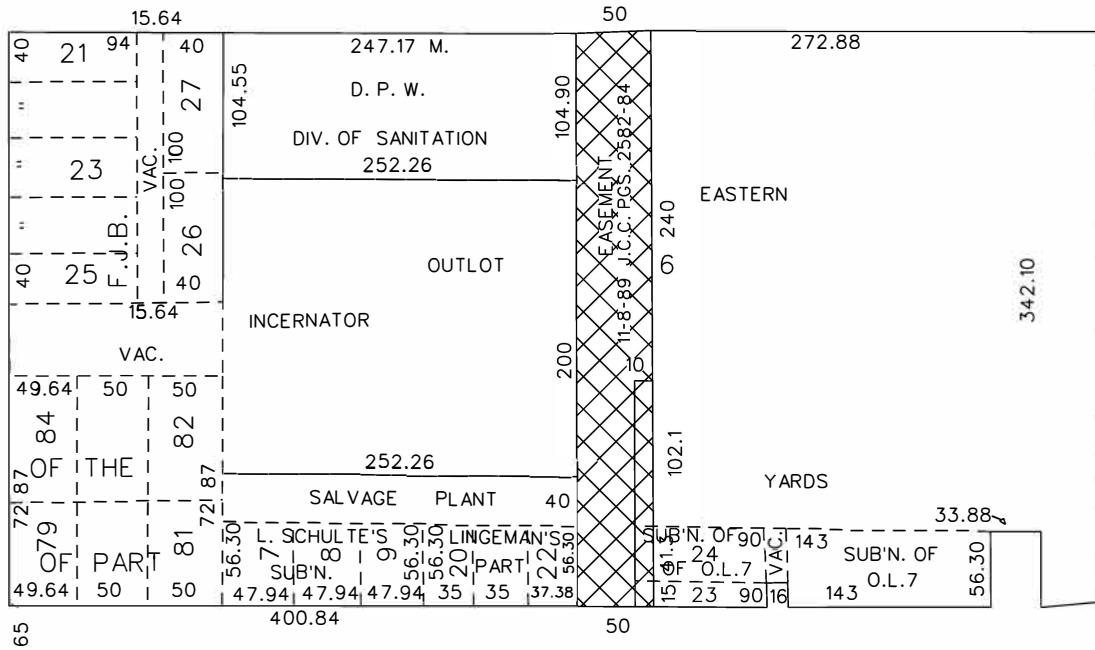
