RE: Request to maintain closure of a 120 foot portion of Cambridge Avenue between Cherrylawn and the first alley west. Original Petition No. 540 dated May 21, 2015 [Copy Attached]

Dear Mr. Dean,

I am writing on behalf of all abutting property owners requesting that the City Council approve extending the temporary closure of Cambridge Avenue, 50 feet wide, from Cherrylawn Avenue, 75 feet wide, to the north south public alley (now an easement) 18 feet wide, first west of Cherrylawn Avenue. This request is being made to reduce traffic flow through the residential neighborhood from students, faculty, staff and visitors to the school, expand a parking lot and improve site security.

Although it is the preference of all abutting property owners to permanently vacate Cambridge Avenue from Cherrylawn Avenue to Ohio Street subject to utility easements we are requesting an extension of the temporary vacation approved by the Detroit City Council and Mayor in 2015. At this time we are requesting the temporary closure be extended for an additional 5-year period.
