We do use the alley that is located between our two properties for continuing safety and security.

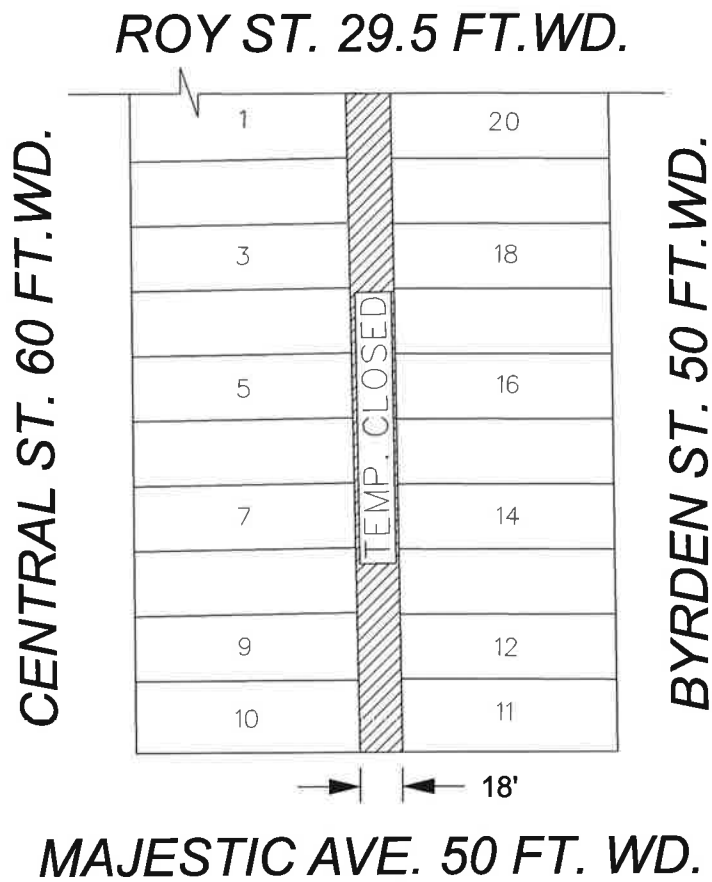
