- Proposed underground encroachment for an existing underground vault into W. Montcalm public right-of-way.

Giffels Webster, 28 W. Adams, Suite 1200, Detroit, Michigan 48226 on behalf of Kraemer Design Group, 1420 Broadway, Detroit, Michigan, 48226, respectfully requests the following encroachments into the public rights-of-way on the north side of W. Montcalm, and the west side of Park Avenue.

- Above grade encroachment for the existing planter begins 3.00 feet from the south-east corner of 2305 Park Ave property line. The encroachment extends up to 1.60 feet (width) into the W Montcalm Street public ROW on the South-East side of the property. The encroachment will extend from 0.50 feet above existing grade to 4.16 feet above existing grade (the encroachment is 3.66 feet in total height). The planter has a length of 15.00 feet.
- Above grade encroachment for the existing planters begins 36.33 feet from the south-east corner of 2305 Park Ave property line. The encroachment extends up to 1.60 feet (width) into the W Montcalm Street public ROW on the South-East side of the property. The encroachment will extend from 0.50 feet above existing grade to 4.16 feet above existing grade (the encroachment is 3.66 feet in total height). The planters have a total length of 41.00 feet.
- Above grade encroachment for the existing planters begins at 2.25 feet from the northeast corner of the 2305 Park Ave property line. The encroachment extends up to 1.33 feet (width) into the Park Ave public ROW on the northeast side of the property. The encroachment will extend from 0.50 feet above existing grade to 4.33 feet above the existing grade (the encroachment is 3.83 feet in total height). The planters have a total length of 36.00 feet.
- Above grade encroachment for the existing planters begins at 53.85 feet from the northeast corner
 of the 2305 Park Ave property line. The encroachment extends up to 1.33 feet into the Park Ave
 public ROW on the northeast side of the property. The encroachment will extend from the existing
 grade (0.00 feet) to 4.33 feet above the existing grade. The planters have a total length of 36.00
 feet.

Giffels Webster, 28 W. Adams, Suite 1200, Detroit, Michigan 48226 on behalf of Kraemer Design Group, 1420 Broadway, Detroit, Michigan, 48226, respectfully requests the following encroachments into the public rights-of-way on the north side of W. Montcalm, and the west side of Park Avenue.

- Above grade encroachment for the existing awning begins 18.25 feet from the south-east corner of 2305 Park Ave property line. The encroachment extends up to 5 feet (width) into the W Montcalm Street public ROW on the South-East side of the property. The encroachment will extend from 6 feet above existing grade to 12 feet above existing grade (the encroachment is 6 feet in total height). The awning has the length of 16.67 feet.
- Above grade encroachment for the existing awning begins at 43.76 feet from the northeast corner of the 2305 Park Ave property line. The encroachment extends up to 10 feet into the Park Ave public ROW on the northeast side of the property. The encroachment will extend from 6 feet above existing grade to 11 feet above the existing grade (the encroachment is 5 feet in total height). The awning has the length of 7 feet.




