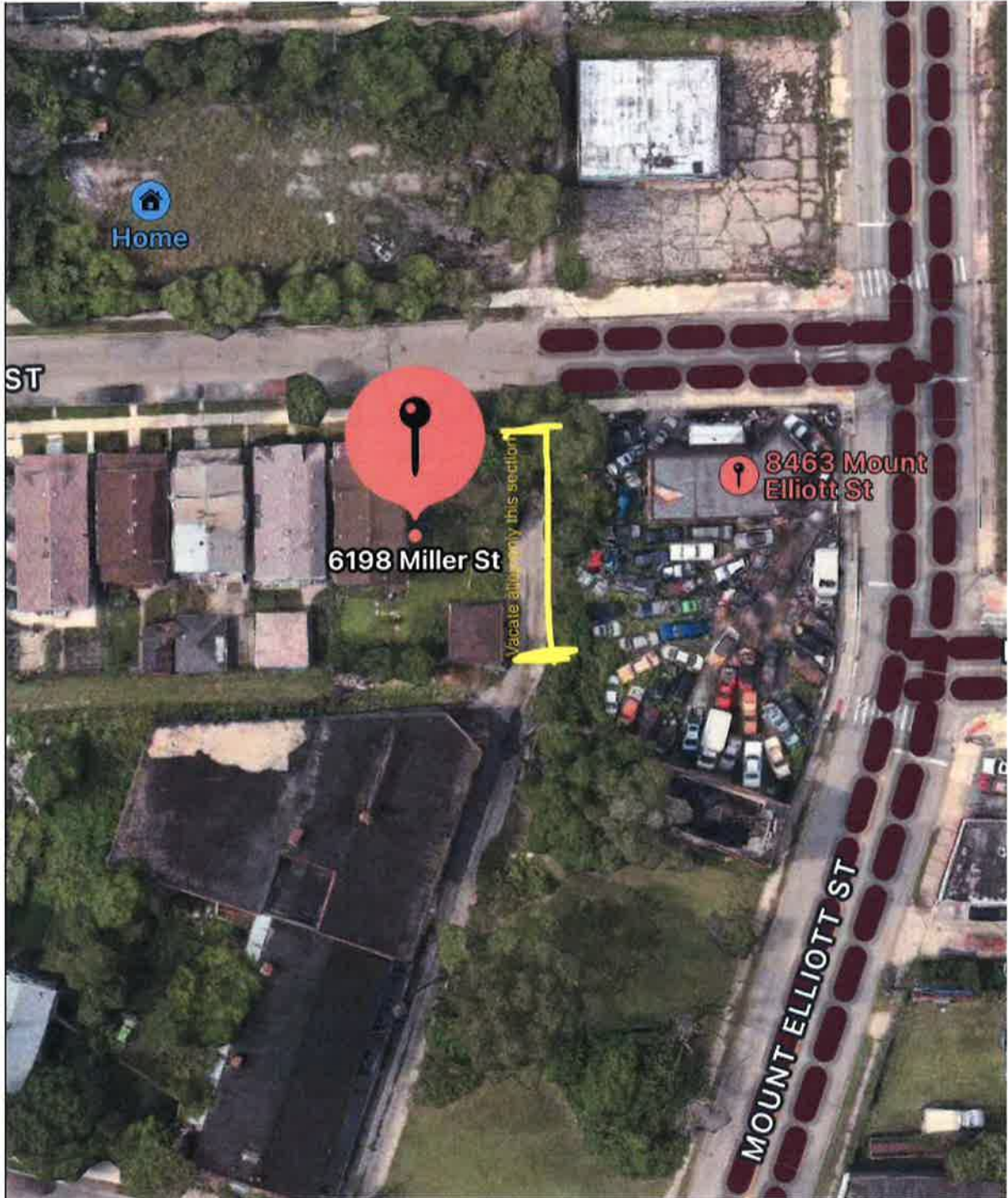
I want to vacate the alley next to my home at 6198

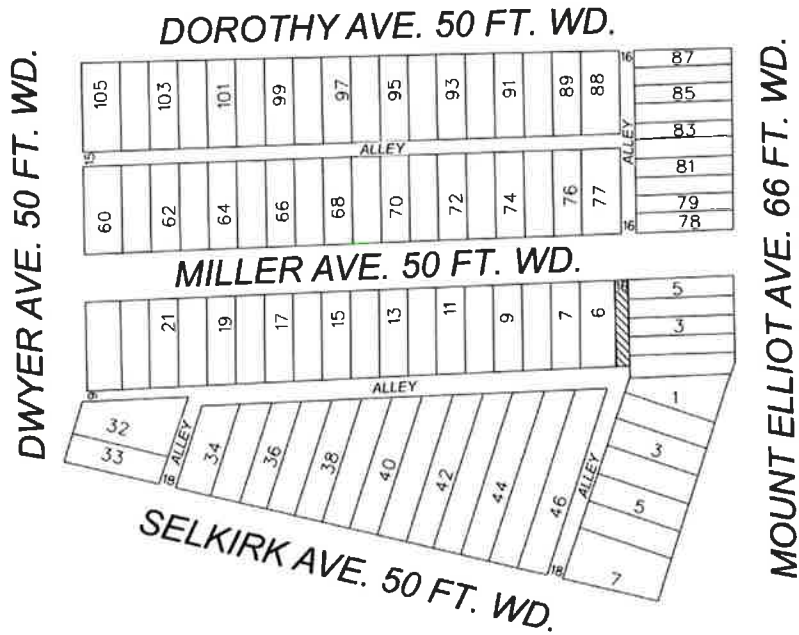
