Giffels Webster, 28 W. Adams, Suite 1200, Detroit, Michigan 48226 on behalf of 1145 Griswold Street LLC, 401 S Washington sq. Suite 102, Lansing, Michigan, respectfully requests the following encroachments into the public rights-of-way in the block bounded by Griswold Street, Michigan Avenue, State Street, Washington Boulevard:

- Proposed above ground encroachment for a canopy from 9.9 feet above grade to 11.6 feet above grade extending 8.4 feet into the Griswold Street right-of-way.
- Proposed above grade encroachment for a canopy 9.4 feet above grade to 12.8 feet above grade extending 7.6 feet into the State Street right-of-way.


