Commencing at the Southeast corner of the intersection of Greenlawn Avenue (50 feet wide) and Cortland Avenue (50 feet wide), also being the Northwest corner of Lot 70 of "West Lawn Subdivision", as recorded in Liber 31 of Plats, Page 68, Wayne County Records, Wayne County, Michigan, thence S01°58'54"E 540.00 feet along the East Right-of-Way line of said Greenlawn Avenue to a PLACE OF BEGINNING; thence N88°01'06"E 106.00 feet along the North line of Lot 52 of said "West Lawn Subdivision"; thence S01°58'54"E 201.53 feet along the West Right-of-Way line of an Alley (8 feet wide); thence along the arc of a 272.50 foot radius non—tangential circular curve to the left, with a central angle of 23°29'19", having a chord which bears S70°52'13"W 110.93 feet along the Northerly Right-of-Way line of Oakman Boulevard (variable width); thence NO1°58′54″W 234.24 feet along the East Right-of-Way line of said Greenlawn Avenue to the Point of Beginning, being all Lots 45-52, inclusive, including vacated alley in rear of Lots 46-48, inclusive, of "West Lawn Subdivision", as recorded in Liber 31 of Plats, Page 68, Wayne County Records, Wayne County, Michigan, and triangular remainder resulting from said vacation of the platted alley and dedication of North-South alley, containing 0.52 acres of land, more or less, being subject to any terms, conditions, or restrictions of record, if any.
