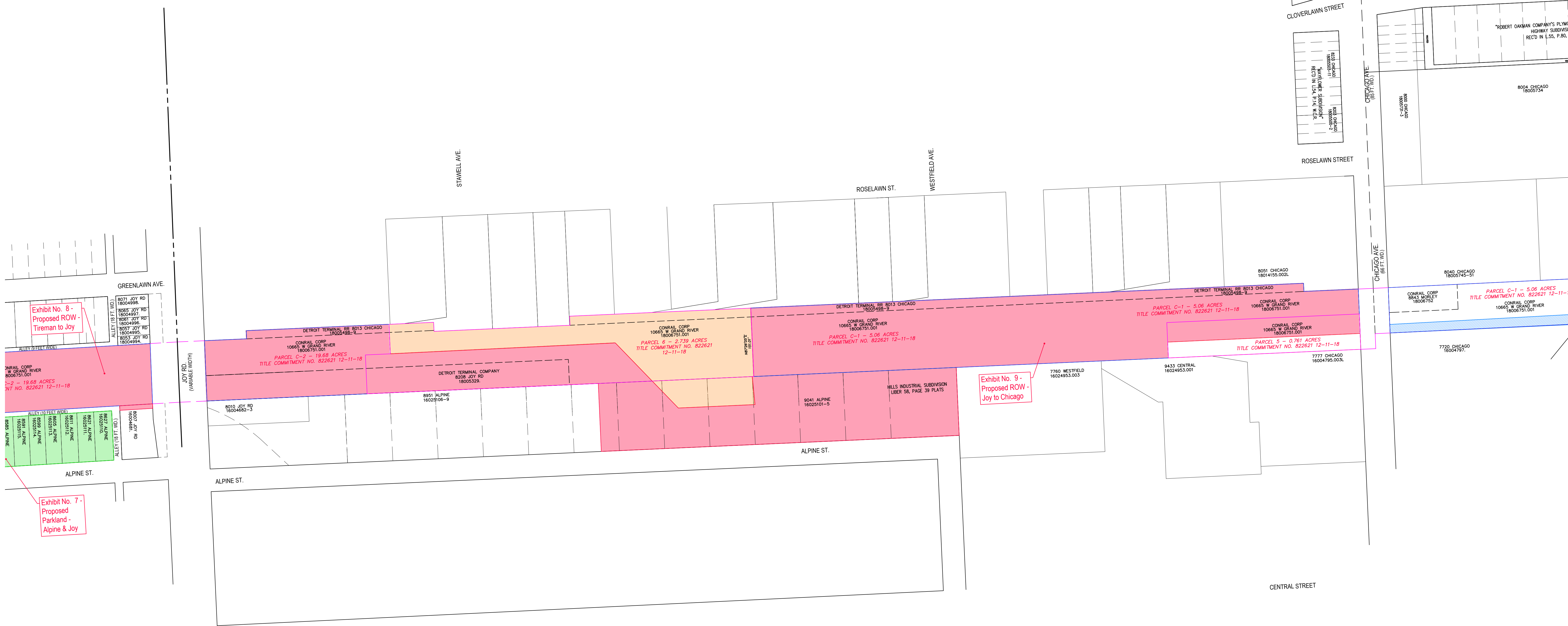

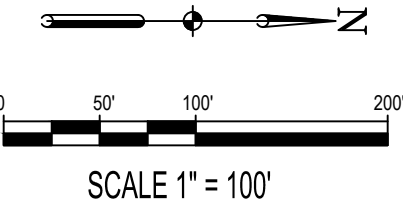

PROPOSED PARCEL CONVERSIONS CHICAGO TO GRAND RIVER AVE.



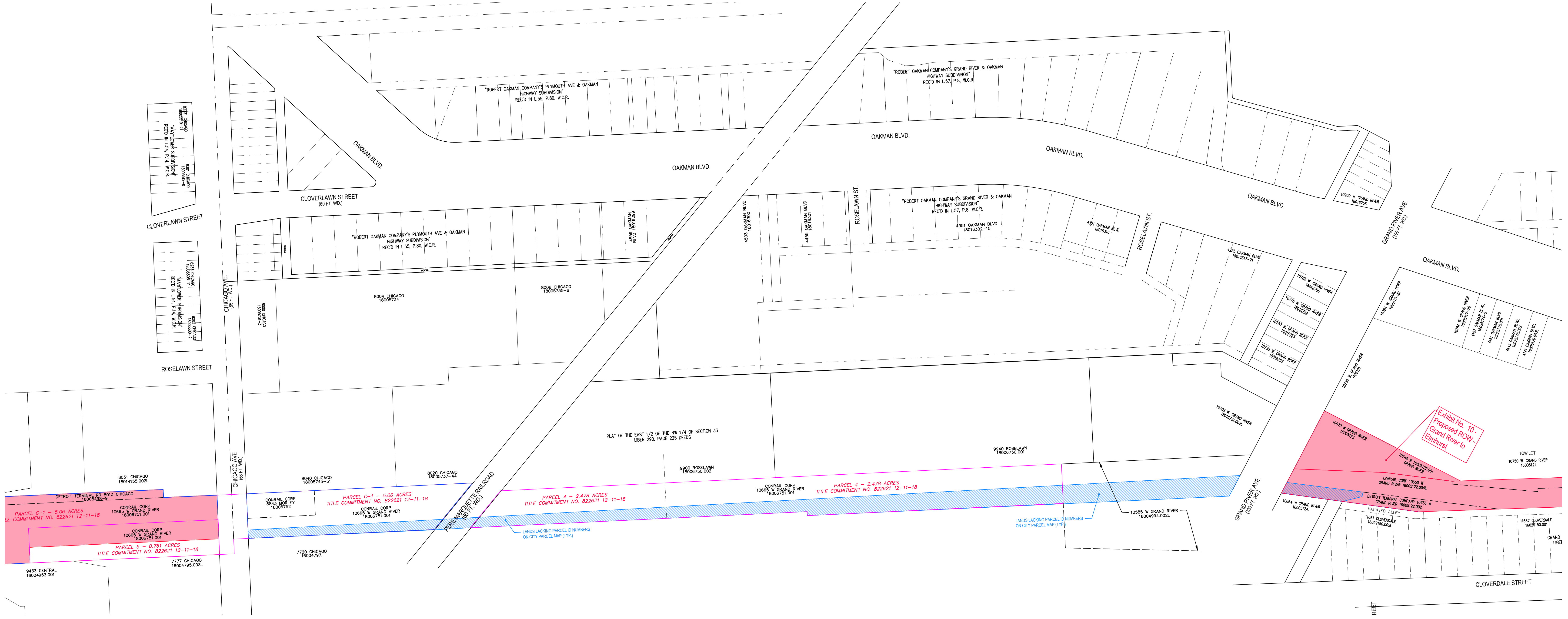

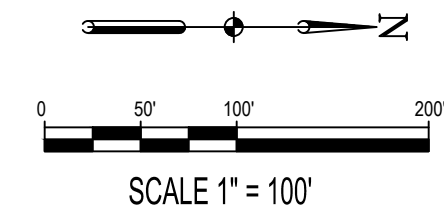

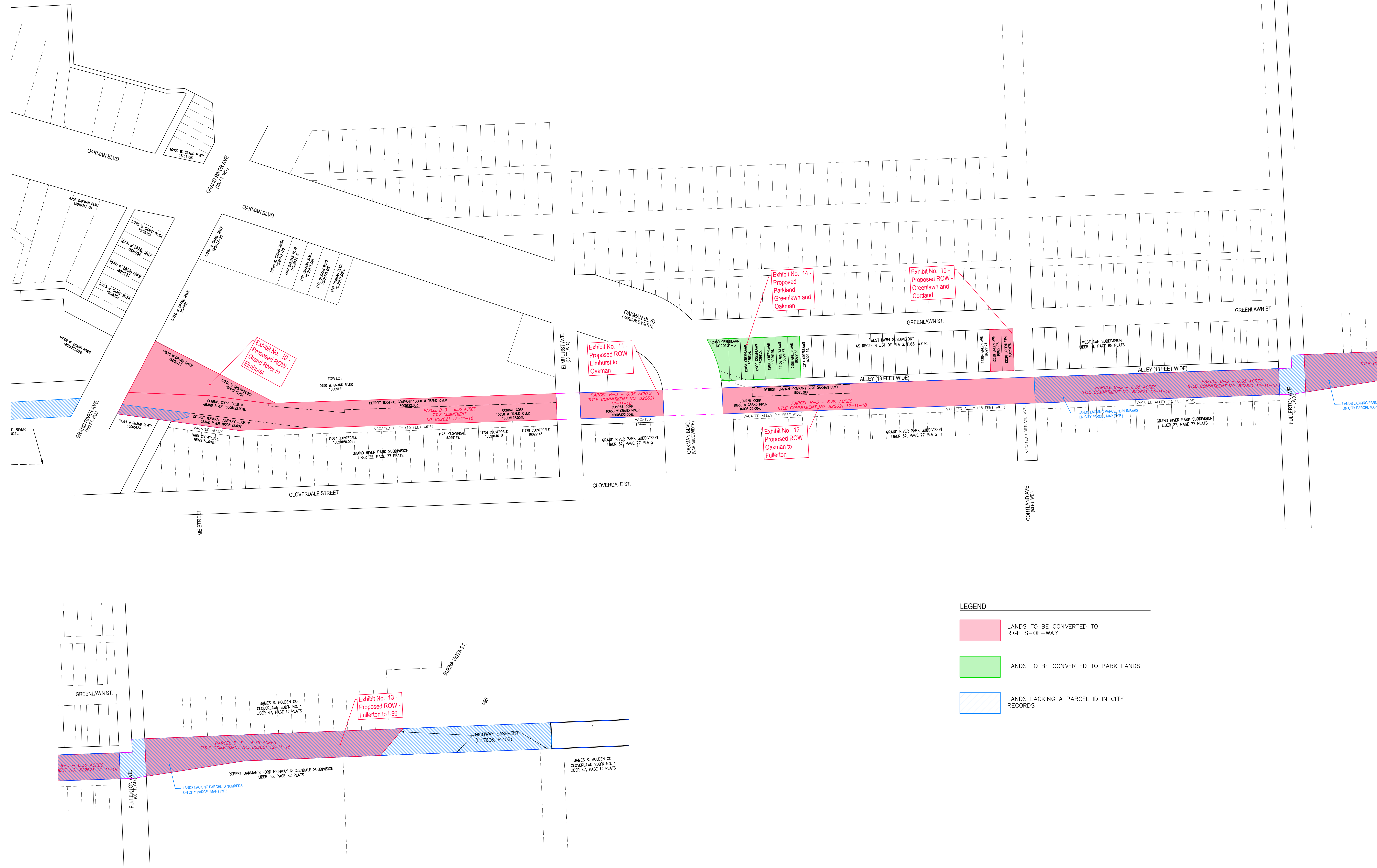
