

AECOM proposes the advancement of 7 soil borings to be developed into monitoring wells and soil gas wells (3 monitoring wells in the alley to the south of 18321 Eight Mile Road, 3 soil gas wells adjacent to the monitoring wells in the alley to the south of 18321 Eight Mile Road, and 1 monitoring well in the right-of-way to the west of 18321 Eight Mile Road). An additional soil boring will be completed in the right-of-way to the north of 18321 Eight Mile Road. Please refer to the site map for the proposed locations.

All monitoring wells and soil gas wells will be permanent and finished in place with concrete, level with the surrounding area. Soil borings will also be finished in a similar fashion.


All investigation derived waste will be stored at 18321 Eight Mile Road, Detroit in 55-gallon drums until a waste pickup can be scheduled.
