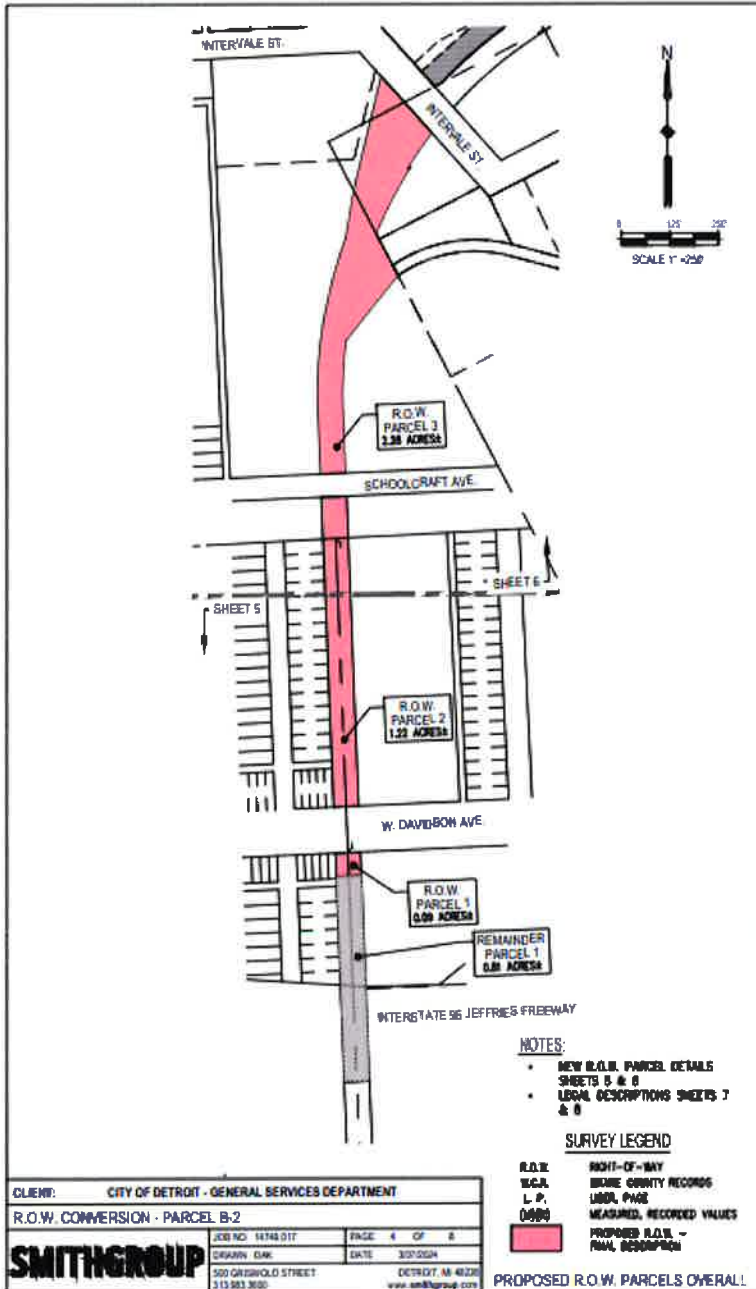

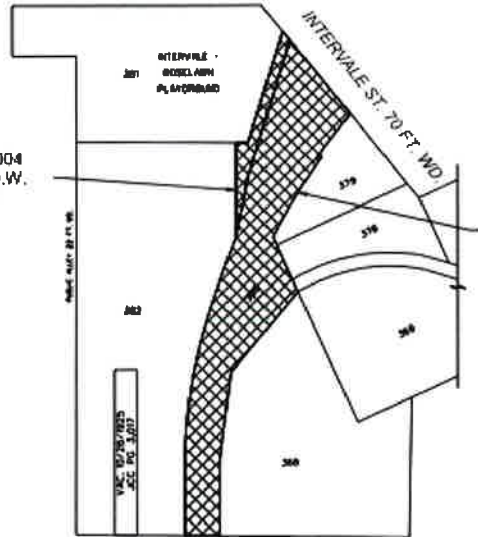

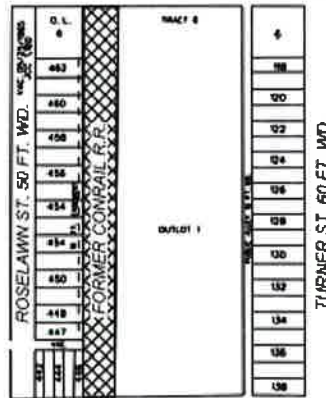

 FOR JOE LOUIS GREENWAY

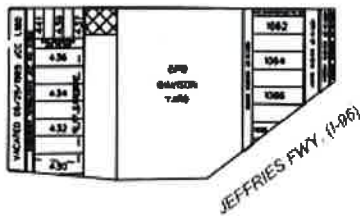


CITY-OWNED CONRAIL R.R. R.O.W.
