Resolved, That the City Controller be directed to prepare appropriate special assessment bonds Nos. 18695 to 18698, both inclusive, dated July 1, 1926, in the total sum of six hundred ninety-six thousand two hundred seventy-three and 52-100 dollars (\$696,273.-52) bearing interest at the rate of 4½ per cent per annum, payable as provided by the Revised Charter of the City of Detroit, and to deliver the same, or in case of sale thereof, the proceeds therefrom, after first deducting such amounts as the said contractors may respectively be entitled thereto in full payment of all liability of the said City of Detroit under the said several contracts.

Any part of resolution heretofore adopted in conflict with the above rate of interest is hereby rescinded.

Gentlemen—This is to advise that deeds accepted by your Honorable Body for Street and Alley purposes have been filed with the Wayne County Register of Deeds:

Quit-claim deed of Michael J. Gallagher to the City of Detroit covering property dedicated for alley purposes, pursuant to resolution adopted June 10, 1924 (J. C. C. p. 1364), described as follows: "the westerly 11.85 feet of lot 1, block 3, of Kengal's Subdivision of that part of O. L. 11, Sub. of Frac. Sec-

tion 29 and 32, T. 1 S. R. 12 E., lying east of the center of Craig Avenue, if extended, as recorded in Liber 9, page 12 of Plats of Wayne County Records, and the easterly 0.15 feet of lot 15 of E. D. Foster's Subdivision of lot 11 frac. section 29 and 32, T. 1 S. R. 12 E., as recorded in Liber 8, page 23 of Plats of Wayne County Records, also the south 12 feet of the westerly 29.55 feet of said lot 15."
